4. Necessary funds will be released in due course.

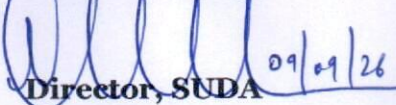

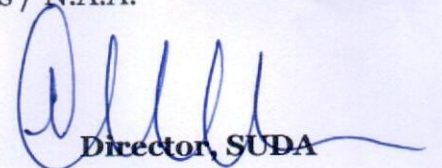

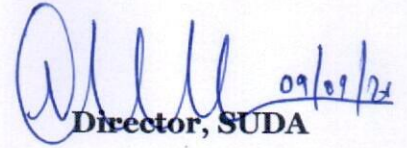

Sub: Allowance of 3% yearly enhancement to contractual Health Officers posted in different ULBs under the UDMA Department

The remuneration of contractual Health Officers posted in different ULBs under the UDMA Department was enhanced from Rs. 41,040/- to Rs. 62,000/- in terms of the U.O. No. 651-Group P2 dated 26.02.2021 of the Finance Department.
