

2. Shortlisted candidates based on academic qualification, experience and computer examination will be called in 1:5 ratio against the declared position for interview.

Sub. : Proposal for appointment of Full Time Entomologist in 06 Municipal Corporations and 'A' & 'B' category Municipalities.

As per decision, 01 Full Time Entomologist shall be deployed in 06 Municipal Corporation and 13 Nos. 'A' and 08 Nos. 'B' category Municipality; thus totaling 27 Nos. List of ULBs is placed at **Flag – A**.

Appointment of such Entomologist is to be done by SUDA and deploy them in the above mentioned ULBs. In this context, sanction of such post at SUDA as well as budget provision for payment of salary may be thought of. Cost implication for payment of salary for one year is **Rs. 129.60 Lakh** (Rupees One Crore twenty nine lakh sixty thousand) only.

Decision may be taken as to whether 100 point roaster will be followed as the total no. of required Entomologist is 27 and the process of selection be done by Municipal Service Commission.
