

Sub. : Strengthening of Health Services in Non-NUHM Towns

NUHM have been implemented in 89 ULBs (having population 50,000 & above including District Towns) out of 125 ULBs to improve the Health status of Urban population with focus on poor population living in listed and unlisted slums and all other vulnerable population such as homeless, rag pickers, street children, rickshaw puller, construction and brick kiln workers, sex workers and other temporary migrants through facilitating equitable access to avail Health facilities by rationalizing and strengthening of the existing capacity of Health service delivery for improving the Health status. Under NUHM both preventive & curative service are being provided through Urban Primary Health Centre (U-PHC).

There are 36 ULBs who are not included under NUHM. Out of 36, 1 newly formed ULB namely Domkal under Murshidabad District, as having population 65,500, will come under the fold of NUHM. The list of 35 ULBs is placed at Flag – A.

Small towns having population less than 50,000 may also be equipped well so that they could provide quality Health care services to the population as being done by bigger ULBs. Hence, preventive & curative Health services of 35 Non-NUHM ULBs may be strengthened through provision of required infrastructure and services so that the population get equitable Health services. Existing Health manpower of 35 ULBs is placed at Flag -

Suggested proposal for improving the Health services in those towns are as under:

- Construction of U-PHC including laboratory facility for each of 34 ULBs.
- Renovation of existing HAU with laboratory facility to function as U-PHC in 01 ULB (Pujali Municipality).
- U-PHC based installation of computer, printer, other accessories and internet connection for 35 U-PHCs.
- Special outreach camp @ 3 camps per month.
- Deployment of Medical Officer, Pharmacist & Lab. Technician @ 1 each per U-PHC for 35 U-PHCs.

The estimated cost is Rs. 2964.31 lakh (Rupees Twenty nine Crore sixty four lakh thirty one thousand) only for one year. ULB-wise detailed cost sheet and summary cost sheet is placed at Flag – 13.
