**Sub: Irregularities in the process adopted by the Chairman Habra Municipality for engagement of personnel in different posts for community based Primary Health Care Services [in 68 NON KMA Urban Local Bodies] under HHW Scheme of Habra Municipality .**

Sir ,

With due respect I would like to take the opportunity to let you know that the way through which engagement of personnel for the community based Primary Health Care Services in Habra municipality have been made recently . It may be stated that the entire process was not only wrong but also unethical Improper and illegal.

The subject was never discussed thoroughly in any of the Board Meetings of the councilors. It is noteworthy that the Board meeting is not convened regularly as per Bengal Municipal Act 1993 . [ The date of last two Board Meeting is convened on 23/2/07, 29/6/07 ..... respectively ]. The entire matter was kept in hide for a long time and the engagement process has been completed in a hurried way without communicating the same to the opposition members of the Board.

Practically the process of engagement of personnel was completed ignoring the government guidelines. I would request you to look into the matter immediately so that the proper judgment may be effected in favor of deserving candidates.

Moreover the formation of the panel for interview board for the engagement was not as per government guideline's (eg Local Committee Secretary of C.P.I.(M) was included in the interview board as representative of Local MLA) . How funny it was? Can we expect proper Judgment in this way ? Can a person take an interview , award marks or ask questions or be an expert , who is not competent enough in all respects .

An objection describing the details was placed before the state Urban Development Agency (SUDA) Health wing ILGUS Bhawan Salt Lake Kolkata , who has been entrusted to supervise the entire matter with a request for taking necessary action. But it is a matter of regret that the entire process has been completed without responding to our protest.

Under these circumstances I would like to request you to look into the matter giving an utmost priority for abandonment of such evil practice of the present authority of Habra Municipality .
