Health component of KUSP has undertaken a no. of innovative programmes i.e School Health Check-up for 126 ULBs , Adolescent Health Care Programme for 40 KMA ULBs in addition to DPRs for other Health activities. Proposal for Health check-up of conservancy workers of 126 ULBs are also in the pipeline. All these programmes need extensive follow-up with the ULBs in order to complete the work within schedule time period.

Sri S.K.Lahiri is well acquainted with all the community based Health programmes and the ULBs in respect of implementation , monitoring and supervision.
