Placed herewith communication of the Chairman, Bongaon Municipality bearing no. BM 616 dt. 15.05.2010 regarding selection of new HHWs along with panel candidate. The Chairman stated in his letter that :

- As per this office memo no. SUDA-Health/63 ULBs/06/181(60) dt. 13.11.2006. 45 no. of candidates (34 regular and 11 panel) were selected & trained. After completion of training, 34 no. of HHWs had been engaged.
- In first phase 5 nos. of FTS were selected and engaged resulting in 5 vacancies for HHWs, which were filled in from the panel candidates, leaving 6 nos. of candidates in panel.
- Out of 6 empanelled candidates, 4 left for ICDS job, thus leaving 2 candidates in panel list.
- The ULB during course of time sacked 1 HHW who has filed a case with Hon'ble High Court. Though the matter is sub-judice, the ULB has already engaged 1 panel candidate to fill up the vacancy out of remaining 2 empanelled candidates; thus leaving 1 candidate in panel list.
- In subsequent phase, 2 more no. of FTS were selected and engaged resulting in 2 vacancies for HHWs. This vacancy could not be filled by the ULB as there is only one empanelled candidate.
- Moreover, no. of wards has been increased from 21 to 22.
- This matter was discussed in the meeting of MHFWC held on 20.04.2010 and decision taken for obtaining approval from SUDA for selection of panel candidates @ 1 / ward i.e. 22 nos.

**Justification for selection of panel candidates :**

- At present scenario, 1 more HHW is required to fill up the vacancy and panel list may be kept @ 10% of total sanctioned no. of HHW i.e. 4; totaling 5 nos.
- But in the recent household BPL survey, required of no. of HHWs are 40, through this matter is pending for decision with the Dept. of MA & DHFW. On the basis of which total further required no. of HHWs will be 11.

Under the circumstances stated above we may agree to selection of panel candidates by the ULB for 11 nos. instead of 22 as proposed by the ULB. The validity period of the panel may be decided by the BOC.
