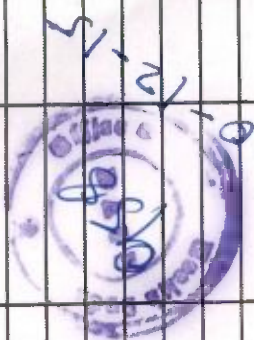

Please refer to the above I am to submit the following facts for your kind information.

- i) That we have provision of 2 (two) Medical Officers under IPP-VIII (Extn.) as per sanctioned norms.
- ii) That we had one Medical Officer and as we were in acute need of another Medical Officer, we appointed Dr. Amlan Roy vide this office Memo No. 142/IPP-VIII (Extn.)/04/11 dt. 09.11.2011 who applied with the Xerox documents of his qualification and who found as a practicing Physician in this town before joining to this Poura Hospital & Matrisadan as one Medical Officer and joined on 11.11.2011.
- iii) That vide this office Memo No. 231/IPP-VIII (Extn.)/04/12 dt. 26.03.2012 Dr. Amlan Roy was asked to produce his documents to C.M.O.H. as desired by his office vide Memo No. 854 dt. 26.03.2012 and also to this office.
- iv) That as he failed to comply the above again reminder was issued from this office under this office Memo No. 234/IPP-VIII (Extn.)/04/12 dt. 02.04.2012 giving him further time upto 10.04.2012 where the C.M.O.H. allowed him time upto 18.04.2012 vide his office Memo No. 962/1 dt. 03.04.2012. He failed to comply with those requirements.
- v) That as Dr. Amlan Roy was absent from service since 19.03.2012 and all the sent documents came return to this office by the Postal Deptt. which were sent under Registered Post.
- vi) That considering the above conditions and his negligency to duties "**Termination order**" was issued against his service as "Medical Officer" to Poura Hospital & Matrisadan with retrospective effect from 19.03.2012 i.e. from the day of his absent from duties and was sent to him under "**Postal Registration with A/D**" which was also came return as non deliver. However, since 19.03.2012 he had no relation with this Matrisadan Hospital as Medical Officer. It is to mention here that the copies of the above termination order was sent to you along with other like the previous occasions of appointment letter.
- vii) That on 18.06.2012 under his Memo No. 272/ADM(C) Addl. District Magistrate, Dakshin Dinajpur (Development) asked to submit the documents where he desired to have the further investigation of appropriate authorities. We duly complied with under this office Memo No. 279/IPP-VIII (Extn.)/38/12 dt. 22.06.2012. Till date we have not received any further instruction from his end.

Under the above circumstances now I am sending herewith all the Xerox copies of the documents available in this regard and solicited your kind guidance for taking any future course of action.

This is to inform you that a complaint was received to the effect that one Mr. Amlan Roy was functioning as Resident Medical Officer in Matri Sadan run by Balurghat Municipality and the said R.M.O. does not have any Medical Registration Certificate.

The matter was sent to the Chief Medical Officer of Health, Dakshin Dinajpur for investigation and verification. It was subsequently learnt that hearing such investigation the said person absconded.

From the reply of C.M.O.H., Dakshin Dinajpur Vide his No. 1474, dated 12.06.2012 it appears that Mr. Amlan Roy who was claiming to be a holder of MBBS Degree after passing from National Medical College and also M.D.(IM) from A.I.I.M.S. have not been found registered in the Database maintained by the West Bengal Medical Council. Since there is a chance that the said person might do similar practice in other areas with the said documents which are in all likelihood fake and as a result, many percussions human lives are exposed to danger. It is necessary to initiate further steps against the said person.

You are, therefore, requested to furnish the other details including his permanent address, other testimonials on academic career, photographs and any further details or his telephone or mobile number which you obtained from him before his engagement, so that the matter can be sent for further investigation to the appropriate authorities.
