Placed herewith communication dt. 07.01.2017 of Dr. Pralay Kumar Saha, Health Officer, Jalpaiguri Municipality bearing no.103/MA/C-10/3S-17/2014(Pt.) dt. 13.02.2017 of the Joint Secretary, Municipal Affairs Branch, Dept. of UD & MA (at **Flag-A**) along with a communication of the Chairman, Barasat Municipality addressed to the Hon'ble MIC, UD & MA.

Joint Secretary, UD & MA Dept requested Director, SUDA to communicate with the Mission Director, NHM, DHFW for extension of tenure service of HO, Barasat Municipality.

In this context, this is to state that Dr. Tapabrata Chowdhury was engaged to the post of HO by Barasat Municipality on regular basis on contractual remuneration, followed by appointment as Health Officer as per Notification no. 522/MA/0/C-9/3R-1/2004 dt. 21.09.2007 (at **Flag-B**) of the Dept. of Municipal Affairs. Fund for salary of Health Officer was released by the Department directly through Treasury. The Health Officer retired from the said post w.e.f. 31.12.2016.

During his tenure as HO, he was given responsibility of Nodal Officer, NUHM by the Chairman, Barasat Municipality. Furthermore, there is no post of Health Officer exist under NUHM. Hence, it seems that communication to MD, NHM in this regard is out of context.
