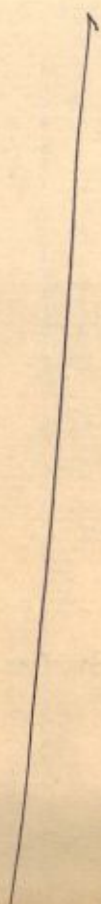

Comments of Health Wing, SUDA on demands placed by Sara Bangla Poura Swasthya Karmi Union, Bhadreswar, Hooghly are given below :

Demands	Comments

Problems faced by Health Workers towards delivery of Health services may be monitored by the respective Ward Councillors and be placed before the <sup>that Councils meet as well as</sup> BOC meeting for its solution.
কন্টিনজেন্সি বাবদ অন্ততঃ মাসিক ১৫০ টাকা দিতে হবে।	An amount of Rs. 3,500/- per month is being allotted per Health Administrative Unit (HAU) which caters 6 to 7 Sub-Centres (SC). Hence, Rs. 1,500/- per SC per months may be allotted by the respective HAU, if deemed necessary.

ছাতা, ব্যাগ, কাপড় সময় মত দিতে হবে।	Uniform, Kit bag and Umbrella had already been provided by CMU twice earlier. Recently CMU has accorded AA & FS for the said items for 3 <sup>rd</sup> time. Department may keep provision in the budget for the same items at two years interval.

অতিরিক্ত ছুটি।	Sanction of leave for additional 15 days in a year as prayed by the Health Workers is a policy decision. If decision taken in affirmative all other functionaries may also be granted for enjoying additional leave.

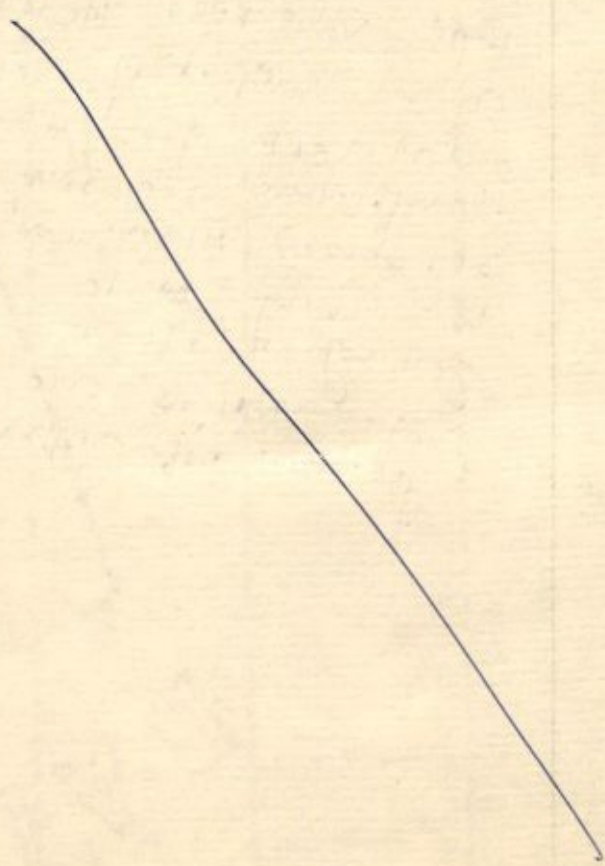

Sub. : Engagement to the post of GDA at MH under UPHCS (erstwhile IPP-VIII), Bhadreswar Municipality.

Placed herewith communication of the Chairman, Bhadreswar Municipality vide no. Health/3488 dt. 03.06.2014 addressed to the candidate for engagement as GDA at MH under UPHCS w.e.f. 10.06.2014 at a fixed honorarium of Rs. 4,062/- p.m. with a copy to Director, SUDA.

The said communication of the Chairman raises two issues which is as under :

- Whether such engagement require prior approval of the Department.
- The fixed honorarium of GDA under UPHCS is Rs. 3,000/- p.m., whereas the appointment letter spells out the honorarium to the tune of Rs. 4,062/- p.m.

Policy decision regarding engagement to the different posts under UPHCS is pending from the Department. It is not possible to find out the amount of payment made / are being made to the category of the personnel from the SOE / UC submitted by the ULBs.

In the instant case, if the letter is issued to the Chairman re regarding rate of honorarium, the said engagement is supposed to be accepted by SUDA indirectly and this may create precedence with regard to approval for engagement of personnel under UPHCS.
