Sub. : Filling up of the vacant post of Health Officer at Gayeshpur Municipality.

Enclosed herewith communication of the Chairman, Gayeshpur Municipality bearing no. GM/GL HEALTH F-153/1377/2009 dt. 16.04.2009 which speaks for itself.

This is to state here that as per GO of Dept. of Municipal Affairs bearing no. 11 C-9/M2A-189/93 dt. 13.01.1994, post of Health Officer had been sanctioned for Gayeshpur Municipality the criteria of selection had been fixed in respect of (i) Age - not below the age of 25 years and above the age of 60 years on the 1st January, 1994; (ii) Remuneration - a consolidated amount of Rs. 4,000/- per month. Retired Govt. Officer allowed to draw pension in addition to consolidated pay. (iii) Terms of appointment - One Health Officer be appointed by Municipal Affairs Dept. for a period of two years subject to maximum age limit of 60 years. Provided that such panel of candidates shall remain valid for one year or earlier as may be determined by the Selection Committee and empanelment in such panel is no commitment for such appointment.

The Selection Committee as per GO no. 335/C-9/M2A-28/93 dt. 1st October, 1993 constituted CMOH or his representative not below the rank of Dy. CMOH - Chairman; Officer not below the rank of Dy. Magistrate and collector nominated by the concerned DM - Member; Chairman of the concerned Municipality - Member and Dy. Asstt. Director of Local Bodies of the concerned division - Member Secretary.

Process of selection - The Selection Committee will issue advertisement in local newspaper inviting applications from recently retired WHS Officer and also from locally available private practitioner having the requisite qualification prescribed in Govt. Order and selected the suitable candidates after interview and forward its recommendation to the Dept. of MA.

Subsequently the contractual pay of Health Officer had been enhanced to Rs. 8,000/- p.m. Dr. Agni Bhattacharjee was appointed in the post of Health Officer as per Notification no. 168 C-9/M2A-189/93 dt. 13.05.1994 and she resigned on 31.08.2004. Since then this post is lying vacant. Health Officers appointed under the above mentioned Notification no. had been subsequently engaged in the post of Health Officer in the pay scale of Rs. 8,000/- - 13,500/- with admissible DA, HRA & Medical allowance w.e.f. 01.08.2007 as per GO No. 522/MA.O/C-9/3R-9/2004 dt. 21st September, 2007.

Under the circumstances stated above, advice may kindly be granted for filling up the post of Health Officer as sought for by the Chairman, Gayeshpur Municipality.

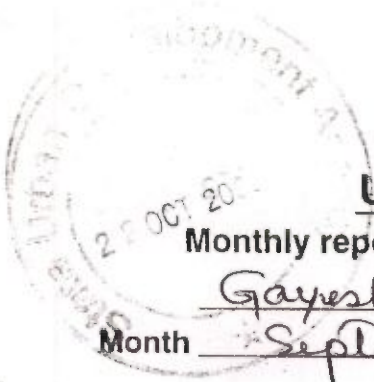


