SUDA has taken over all the health progs. including IPP-VII from KMDA w.e.f. 1.1.2008. It is learnt from the Mpl. that instead of sharing the enhanced remuneration KMDA and UCB, each used to pay separately the full enhanced amount; thus causing double payment of enhanced amount to the incumbent.

Since 01.07.2008, after taking over by SUDA, fund in respect of UM10 is being released taking into consideration the principle of equal share of enhancement. As a result, the UCB is getting less fund as per their version, that is why the UCB has sought clarification.
