Placed herewith a communication of the Chairman, Khardah Municipality vide no. KDH.M/1005/10 dt. 16.11.2010 which is self explanatory.

In this connection this is to mention here that on receipt of complaint lodged by Smt. Sandhya Saha, FTS, CUDP III on (i) non-payment of honorarium and (ii) non-functioning of immunization service from the Sub-Centre since August, 2009, a letter was issued to the Chairman on 05.02.2010 to look into the matter, followed by visit of Dr. S. Basu, APO, Health, SUDA on 22.06.2010 to Khardah Municipality to enquire into it. Dr. Basu submitted a report after visiting the respective Sub-Centre as well as after discussion with Chairman, EO and Smt. Sandhya Saha, FTS. The salient findings of the said report are as under :

- Smt. Sandhya Saha would be paid all her dues by the Municipality and she would not be debarred from her monthly remuneration.
- Smt. Saha would maintain proper dress code, attain weekly meeting regularly on time, perform all her duties of FTS and maintain harmonious working atmosphere in the Sub-Centre.
- Immunisation in Sub-Centre II (CUDP III) had been stopped not because of any personnel issue as alleged by Smt. Saha but temporarily with hold due to administrative reasons like non-availability of MO. However, beneficiaries under coverage of this Sub-Centre are getting all the services from the Sub-Centre of the IPP-VIII which is within close vicinity.

The Chairman in his letter stated the following against Smt. Sandhya Saha, FTS, CUDP III :

- In spite of repeated requests from the Municipality Smt. Saha deliberately ignored the direction of the Authority and to obey the rules regarding use of uniform.
- Irregular attendance as well as failure to carry out the responsibilities as FTS causes anxieties for rendering medical assistance to the public.
- Smt. Saha did not withdraw her salary including arrear till date from the Municipality in spite of intimation given to her.

On the above ground, the Chairman said that the Municipal Authority is reluctant to continue her service as FTS and sought suggestion from SUDA regarding the procedure to be adopted for dismissal of her service from the Municipality.


