
Sir,

Renovation of HAU buildings is one of the agenda under the Urban Health Improvement Plan to enable it to render the following services :-

- i) Specialized service delivery for detection and management of RTI & STI cases.
- ii) Safe MTP services a) up to 10 weeks at HAU level (beyond 10 weeks at Maternity Home)
- iii) Preliminary laboratory investigations for screening of RTI & STI cases.
- iv) Organizing female sterilization /IUD insertion
- v) Training programme to the service providers of the area.

One HAU building has been identified in your Municipality for rendering the above services on a pilot basis vide minutes of the meeting of the Health Officers etc. held on 17.04.2003 and communicated to you vide this office memo no.99(30)/KMDA/UHUIP/P-136/2003 dtd. 26.05.2003.

The renovation works in the specified HAU building would include one small Operation Theatre, Sterilization Room, Observation Room, Store Room, Counselling Room, Staff Room and two Toilets (one for gents and other for ladies) and such other facilities as you think fit.
