

authorities as yet have not framed any service condition of the petitioners which has laid to serious inconvenience of the petitioners in their employment namely there is no provisions of retrial benefit and pay scale and therefore the respondents are in duty bound to frame a logical service condition of the petitioners after permanent absorbed them in the said post .

- II. For that the respondent authorities all through proceeded upon wrong footings in order to utilising the service of the petitioners who are being deprived of in all respects at the whims of the authorities.
- III. For that the concerned respondents are neither authorised nor empowered to employ any citizen for years together either temporary or part time basis, but in the instant case the petitioners joined the said service with the anticipation that their service will be regularised in due course and they will get regular
.....
Pay scale

pay scale for which they have already spent their best part of life in the said service and it is the legitimate expectation that the authorities should act as a model employer not like a private individual.

IV. For that the petitioners since their respective joining in the said post have been discharging duties after acquiring requisite qualifications but at any point of time the concerned respondents did not considered the petitioners grievances in the matter of permanent employment ; on the contrary the respondents have already taken steps to remove the petitioners from the said service only to appoint the candidates of their own choice in place of the petitioners herein, thereby the petitioners are being deprived of from their legitimate claim and their absorption in the said establishment even they are not getting equal pay for doing equal work like the Class-IV employee of the authority and also they have been discharging their service without having any scale of pay which is not

only illegal and without jurisdiction but the concerned respondents are compelling the petitioners to act as a bonded labour which is in violation of article 23 of the Constitution of India.

V. For That the respondent authorities cannot illegally remove the petitioners from their service in order to place the other candidates who are their favoured child.

24. Your petitioners state that there is common cause of action arose in the said writ petition as such the petitioners are filing the instant writ petition jointly having common cause of action against the same respondents.

25. That sending of further demand of justice would be empty formalities as the petitioners exhausted all the remedies by making necessary representation.

26. That the petitioners never moved any writ petition before this Hon'ble Court on the self-same cause of action.

27. That this application is made for bonafide and for the ends of justice.

Under the circumstances, your petitioners most humbly pray that Your Lordships may graciously be pleased to issue :-

a) A writ of and/or in the nature of Mandamus by directing the respondents not to interfere the day to day service of the petitioners in any manner whatsoever ;

b) A writ of and/or in the nature of Mandamus by directing the respondents not to give any appointment of other ^{and let} ~~offer~~ removing the petitioners from the said post ;

c) A writ of and/or in the nature of Mandamus by directing the respondents

that the

that the petitioners may be treated at par with the Class-IV Staff of the organisation by regularising the said service as well as by granting all retrieval benefits after the superannuation ;

d) a writ of and/or in the nature of Certiorari by directing the Respondents to transmit and produce the entire records of the case so that a consonable justice may be done by directing the respondents to absorb the petitioners in the permanent post ;

e) Rule NISI in terms of prayers - (a), (b), (c) and (d) above ;

f) An ad-interim Order of Injunction do issue by directing the respondents not to interfere and/or intervene the

g) An Ad-interim Order of Injunction do issue by restraining the respondents from taking any step or further steps from appointing any candidates in place of the petitioners till the disposal of this application ;

h) An Ad-interim Order of Injunction do issue by directing the respondents to regularise the service of the petitioners in the said post with regular pay scale as well as by granting all retriral benefits after due super-annuation as are being granted to the Class-IV Staff of the organisation ;

i) An Ad-interim Order of Injunction do issue by directing the respondents

After the selection of the candidates the next process is to train up them by the Municipality on the basis of the Training Module enclosed.

The training would be for 30(thirty) working days which includes 22(twenty two) days for Class Room Training, 7(seven) days for Field Training and the last day of the Training Schedule would be for examination for the candidates.

During the Training period the trainees would be provided Rs. 10/- as Tiffin allowance and Rs.10/- as conveyance allowance totalling Rs. 20/- per head per day.


The amount may be paid out of UHIP Contingency Fund to the Municipality on reimbursement basis.

In terms of health services under IPP VIII the Maternity Home was constructed by the Maheshtala Municipality in 2000-01 at a cost of Rs. 1.20 Core.

The building is three storied with about 3,000 sq.m. floor area and spread over as follows :-

a) **Ground Floor** :

OPD with five Doctor Chambers, one ECG Room, two Pathological Laboratory Rooms with necessary equipments, one Store Room and one well-equipped O.T.

b) **First Floor** :

16 beds with Doctors and Nurses Rooms, Store Room, Labour Room and four cabins.

c) **Second Floor** :

Eight Doctors and Nurses quarters.

The Maternity Home is well connected by road and rail having steady transportation coverage. The hinterland of the Matrisadan includes two adjacent Municipalities (Budge Budge and Pujali), Panchayt areas (T.M. Block, Budge Budge Block) and some adjacent areas of the Kolkata Municipal Corporation.

2. Purpose of Expression of Interest

The Municipality now runs the Matrisadan with its minimal staff infrastructure. There are now some part time contractual doctors, some GNM & Non-GNM nurses on contractual engagement and some other staff on contractual engagement.

The Municipality has not that professional skill and competence to run the Maternity Home with the contractual Medical and non-Medical staff. There are some stumbling blocks rendering running the Maternity Home a difficult task. Therefore, the fanfare with which the Maternity Home was started in 2000-01 has now lost much of its force. Attendance of OPD patients is not upto the expectation. Bed occupancy percentage is very low.

Therefore, the Municipal Authority has decided to outsource the management of the Maternity Home for the gainful use of the Maternity Home and catering effective treatment to the people under the cover of Public Private Partnership where the Municipality with its buildings, equipments, furniture-fixtures as its stake will be a partner and through efficient management of the Maternity Home by the managing partner as its stake.

3. Private Public Partnership Period

The period of Public Private Partnership shall be initially for 10 years with a provision of further extension. There may, however be a provision for initial partnership for more than 10 years upon mutual consent, common terms and understanding provided the Public Private Partnership property cannot be sub-let and/or kept as mortgaged for obtaining institutional finance.

4. Administrative scope and obligations

The managing partner shall run the Maternity Home and ESOPD at its cost in a gainful manner. The managing partner may have the liberty to run the Maternity Home for all kinds of indoor treatment apart form gynecological diseases and institutional birth by providing separate wards for male & female indoor patients.

The managing partner may, subject to written permission of the Municipality, remodel the indoor arrangement for increase of beds & cabins arrangement for male / female wards etc. at its cost. The Managing Partner, however, shall have the liberty to decide the continuance of the existing contractual staff, sweeping agency and security agency or dismissal. There shall be no obligation for retaining the staff.

The obligation of the managing partner shall be in the following sector.

- a) The BPL families and Maheshkala Municipality IPP VIII card holders shall get special discount in respect of bed charges, O.T. charges etc.

The discounted rates, as are now charged from this category of patients, are detailed below. This discounted rate cannot be changed without written consent of the Municipal Authority.

10% of dormitory beds shall be kept reserved for BPL families and Maheshwala Municipality IPP VIII card holders i.e. for the existing 16 beds –02. 10% on extra bed to be arranged.

- b) The bio-medical wastes shall be disposed of as per statutory rule by the managing partner.
- c) The treatment charges, OPD charges, pathological charges shall be displayed in conspicuous places for consumption of the public.
- d) The entire cost of running the Maternity Home including electricity, generator, water supply and statutory licences, maintenance of the premises, replacement and maintenance of equipments and furniture/fixture of the Municipality etc. shall be sole responsibility of the managing partner.
- e) There shall be a Board of Directors for management of the Maternity Home in which the Municipality and the District Health Department shall have representation. The no. of Directors and share of Directorship may be mutually decided.
- f) There shall be provision of emergent ambulance services in referral cases or in emergent need for shifting of patient to other hospital etc.

5. Financial obligation

Annual Consolidated Royalty in the form of land and building usage charge and development charge shall be paid to the Municipality by the managing partner.

The Reserve Annual Consolidated Royalty is Rs.2,50,000/- with a provision of 5% enhancement at every five year block.

6. Termination Clause

The Public Private Partnership may be terminated by the Municipality in consideration of lapses on the part of the Managing Partner as detailed below :-

- a) Failure to provide treatment facility at approved cost to the BPL/Maheshtala Municipality IPP(VIII) card holders – both OPD and Indoor.
- b) Lack of proper disposal of bio-medical and pathological wastes.
- c) Failure to obtain/renew statutory licences.
- d) Use of the building for any non-medical purpose.

7. Credential requirement

- a) The intending party may be an individual firm, partnership firm or a consortium. A copy of certificate of Incorporation as per provisions of the Companies Act is required.
- b) Experience in the management of Hospital / Nursing Home may be submitted with authenticated documents.
- c) The audited balance sheets for the last three years in running hospital / nursing home are to be furnished.

8. Detailed Project Report

The intending party has to submit a DPR covering the following points :-

- a) Fund provision and fund flow for running the Maternity Home and ESOPD.
- b) An analytical approach on the following separately.
 - i) Patient Management System including dieted or non-dieted arrangement.
 - ii) Clinical Support Services System.
 - iii) Common Services System.

9. Submission of Expression of Interest
