From the enclosures, it is gathered that the dept. of MA, in its letter no. 1057-MA/C-10/3S-55/2010 dt. 27.12.2010 (at **Flag-A**) had requested the Chairperson of New Barrackpore Municipality to approach the Health & Family Welfare Dept. along with Detailed Project Report and vetted estimate of the work with a copy to the Dept. It is not known whether the ULB has received any response from DHFW.

Under the circumstances, we may bring this issue to the notice of the Dept. so that the Dept. could request the Chairperson to forward the response of DHFW to process further for execution of the project.
