

Sub. : Extension of the service activities under CUDP III & CSIP for one year w.e.f. 01.04.2009.

As per order of Dept. of Municipal Affairs, all the Health Programmes namely CUDP III, CSIP, & IPP-VIII have taken over by SUDA from KMDA w.e.f. 01.04.2008. In the mean time, it was discussed that budget of all the Urban Health Programmes will come under one umbrella of Dept. of Municipal Affairs. It is learnt that a file has been mooted in this regard by Dept. of MA.

As few days are left to close the FY 2008-09, it is not clear whether we shall move to the parent department who is funding the project i.e. DHFW for CUDP III and Dept. of UD for CSIP or to the Dept. of Municipal Affairs for granting approval for continuation of the activities of CUDP III & CSIP beyond 31.03.2009 for a further period of one year.

In this connection, it is to mention here that KMDA has not provided SUDA any previous correspondences in respect of extension of both the CUDP III & CSIP.
