This is to inform you that an advisory has been issued to the 41 high priority ULBs, identified by the Health & Family Welfare Department, on source reduction of vector and IEC for prevention & control of dengue. District-wise review meetings are being held by the Secretary, Municipal Affairs Department on the development Programmes including prevention & control of dengue. In this context, I am to refer to the review meeting held by Health & Family Welfare Department with 14 ULBs on 01.08.2016. During discussion in the review meetings, it is gathered from the ULBs that the house to house fever surveillance and source reduction may be extended to 10 days instead of 05 days in a month.

Hence, I am directed to request you to increase the no. of days of house to house visit for 10 days per month. Additional fund requirement per month will be Rs. 75,10,750/-. ULB-wise fund requirement is enclosed herewith.
