The inclusion of such employees of D.M.C has been decided as per Resolution No.12 of the 258th meeting of Mayor-in -Council held on 19.03.2012.

To implement the scheme, the employer has to make an additional contribution of 13.61% of the employees salary per month towards E.P.F and Pension Fund of the respective employees.
