

Sub. : Selection of further HHWs at Mal Municipality under CBPHCS

Enclosed the copy of communication of the Chairman, Mal Municipality bearing no. MM/C/62/2008-09 dt. 22.04.2008 which speaks for itself.

This is to state that Mal Municipality selected 16 Regular HHWs and 6 Panel candidates who were trained for 45 days and Regular HHWs (16 nos.) engaged with effect from 02.05.2007. Time to time some of the HHWs resigned and vacant posts had been filled up from the panel candidates. Now the Chairman has intimated that the list of panel candidates has totally exhausted. FTSs selection (4 nos.) out of existing regular HHWs will be held shortly. The would be resultant vacancies of the HHWs due to engagement of FTSs can not be filled in.

Hence, it is most essential to select panel candidates (6 nos.), 4 nos. for filling up of the vacancies and 2 nos. will be kept in panel. After selection, necessary training of the candidates are also required to be taken up by the ULB at their level. The ULB may be informed for such selection by the Municipal Level Health & Family Welfare Committee observing the guideline already followed in earlier occasion.

Placed herewith communication of the Chairman, Mal Municipality bearing no. MM/C/355-A/2009-10 dt. 01.09.2009. From the said letter it is learnt that 16 wards of the ULB has been reduced to 15 after clubbing ward no. 2 & 3 as per notification of the Municipal Election Commission.

As the ULB has already engaged 16 no. of HHWs for 16 wards, in the present situation the ULB has decided to place one regular HHW as leave reserve. This is to mention here that there is no provision for keeping regular HHW as leave reserve.

However, from the recent household survey it is revealed that the BPL population of ward no. - 02 is 1220 and for ward no. - 03 is 753, thus total BPL population of ward no. 02 & 03 is 1973 wherein two regular HHWs instead of one can be deployed. Hence, the issue of keeping regular HHW as leave reserve does not arise.

We may inform the ULB to deploy the 02 (two) regular HHWs of erstwhile ward no. 02 & 03 to serve the total BPL population of 1973 of the newly formed ward no. 02. If agreed, draft letter will be placed accordingly.
