- ➤ In the month of August, another meeting was organized by SUDA with all the ULB's of South 24 Parganas.
- ➤ High level government officials in the rank of special secretary, joint secretary, Deputy Secretary are tagged with 15 ULBs to monitor cleanliness, household visits to address administrative issues for control of Dengue and Maheshtala is one of them.

- ➤ Besides that a untoward incident occurred on 3<sup>rd</sup> November, 2017 due to death of one Shri Rabin Paul and the cause of death is reported to be dengue. This creates a grave law and order situation.
- ➤ Designated officer of that municipality rushed there and make an arrangement for fogging, spraying anti larvae oil, bleaching powder and gave instruction to clean the drains and garbage and his observations are as follows:
  - ❖ Intensify anti-dengue campaign in reported areas by distribution of leaflets, organizing kits street miking etc.
  - ❖ Immediately inspect under construction building, housing project, both running abandoned/closed factories and issue notices wherever applicable.
  - ❖ Direct the health workers to maintain close liaison with hospitals, nursing home, diagnostic centers for reporting of any dengue cases. The hospitals, nursing home and diagnostic centers may be further directed to maintain close liaison with the Municipality.
