

It is resolved that minimum qualification for the post of HHWs is madhyamik. If Candidate with higher qualification is available, it will be given preference.

Notice for selection of HHWs will be published in the Notice Board of this office and other important offices. It is also resolved that the notice will also be published in the local newspaper.


Dates of different steps of selection would be as follows:-

- iii) Date of interview : 24.06.2009

As one post of ANM is vacant for a long time, applications for the post of ANM is to be invited in the same Notification. The qualification and other criteria for the post of ANM will be as per Govt order following which a ANM was previously selected for the Scheme.




