As the original fund is still to be released, there is no question of submission of UC to the department and it will be furnished as and when the fund is exhausted from our end.

Questions raised by the Spl Secretary, UD & MA Department contain two components:

- 1. To whom the bill is to be paid ----As letter has been issued by Director, SUDA to Director, Information and Cultural Affairs, GoWB to float the advertisement in electronic media, payment is to be made to the I&CA Department. It is worthy to note that, three bills had been furnished to SUDA by the advertisement agency itself, not by I&CA Department.
- 2. Utilization certificate for previous allotment under IEC----- In this case note at NSP-1 may kindly be considered wherein it is mentioned that a sum of Rs. 10,82,49,000/- has been received from Deptt. of UD & MA vide memo no. 144(Sanction)/UDMA-13014(19)/2/2018-BDG-MA dt. 06.07.2018 for the purpose of procurement of Larvicidal and IEC. Meanwhile, we have released fund for the same purpose during December, 2017 for calendar year 2018 out of unspent fund of UPHCS with the approval of thethen Secretary, UD&MA Department considering the urgency of upcoming threat of VBD, and the larvicide procured have already been exhausted.

Further to note that, there are numerous proposals are coming regularly from different ULBs for procurement of Larvicidal and those are most legitimate considering the span of programme throughout the year as compared to the duration of previous year. Hence, it is proposed not to utilize this fund for payment of advertisement bill.

Cost estimation of advertisement as well as order issued to I&CA are not available to the U/S, so that divergence of estimated cost and actual bill could be compared.

Therefore, it is proposed that a separate proposal may be send to deptt. of UD & MA for augmentation of budgetary fund with the Finance Department under this Advertisement purpose.


