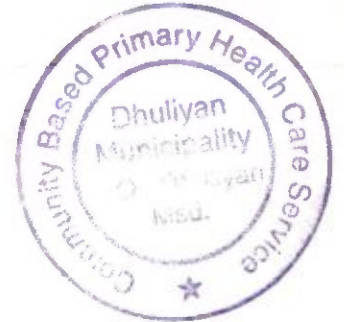

Expected costs on the items may be given as per following break-ups:


