Sub. : Prayer for fund for incurring expenditure on IEC relating to Routine Immunisation at Dhuliyian Municipality.

Placed herewith communication of the Chairman, Dhuliyian Municipality vide no. 168-Health/DM dt. 02.07.2012 on the subject mentioned above.

A meeting was held at Old Circuit House on 14.06.2012 under the Chairmanship of DM, Murshidabad wherein ULBs of Murshidabad District and the undersigned were participated. The issue was strengthening of Routine Immunisation and more fruitful implementation of Pulse Polio Programme. It was discussed that as per NPSP monitored data only 22% children are fully immunized, though the target is 100%. It was felt that outlet for providing Routine Immunisation and mobilization of the community through IEC are to be increased manifold. Following to that the Chairman has submitted a prayer for funding support. Initially the funding support may be provided as detailed below :
