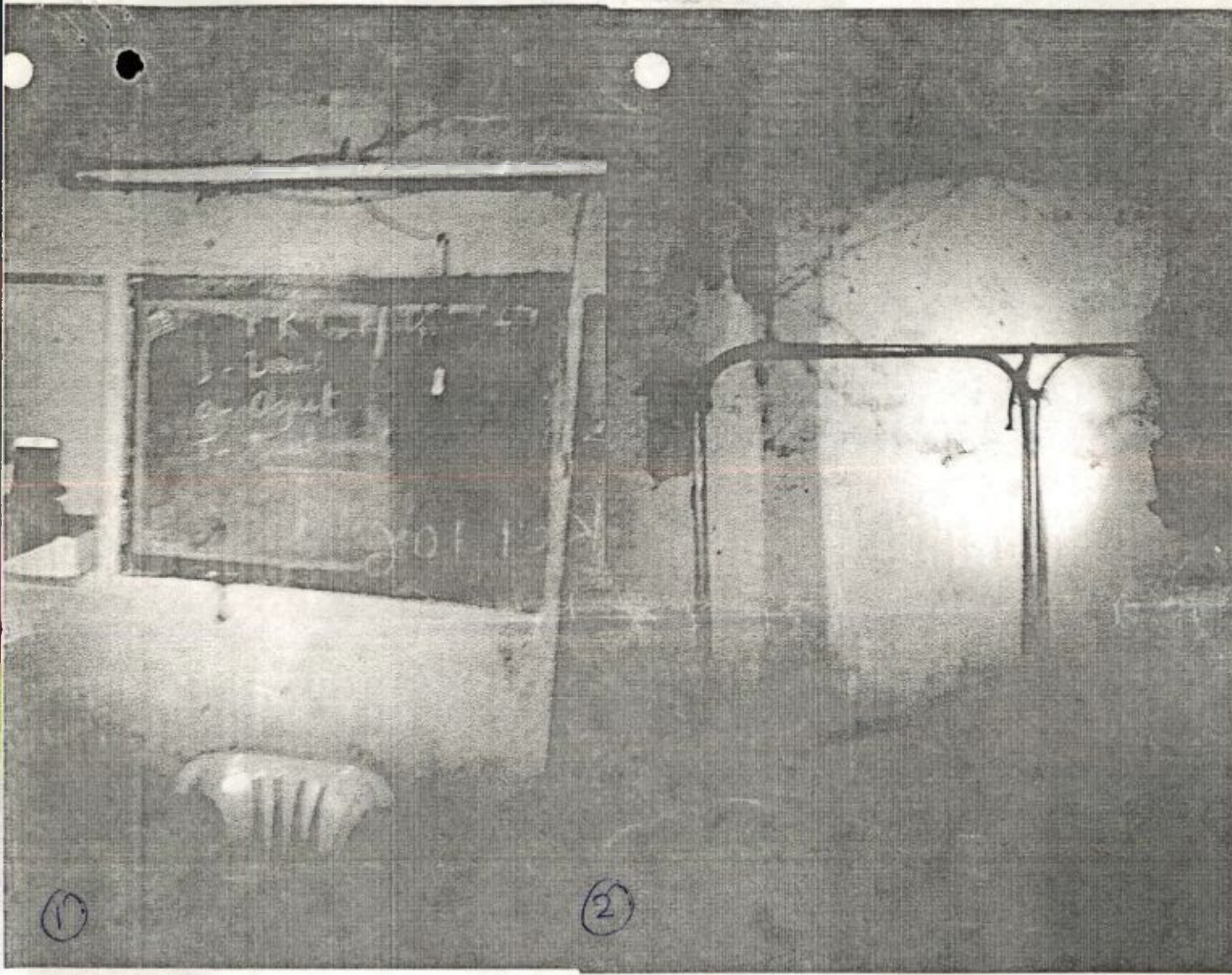

It appears that Asansol Municipal Corporation is absolutely failure to supervise the RCH centre. The reasons are best known to you. Is this the provision to do attendance without performing the duty if not then I am requesting you t verify this and take necessary action in her against to cease such monopoly of a worker.

I hope you will adopt appropriate measures in this regard.

Mohalla Railpar, Ward no.27, Asansol

Sir,

We, the undersigned, are the responsible citizen and residents of Railpar, Jahangiri Mohalla, Asansol. We would like to put forward our views and facts about RCH centre located at Railpar Jahangiri Mohalla, Asansol. A mass petition had been placed before you about the shifting of an RCH centre from well arranged place to a place where there is lack of facilities. In this regard it was detected that the supervisor Ritu Sharma had made this on arrangement by taking Rs 25000/- from the owner and a part she had given to an authority named Siddhartha (Health Department) but no action was taken in this regard.

We see that there runs a shop of mobile and others in the room where RCH centre was existing. The reasons best known to you. As there is no board in the corporation then whether you had passed an order to shift this centre from well arranged place. We want to know who had accord approval to do as such. We came to know from reliable source that Mr Siddharth (Health Dept) had made this arrangement. Ritu Sharma told that Mr Siddhartha is all in all and the whole department is controlled by him. If this room would be under any public concern then it would not easy to avail the owner as such. We think there is must a conspiracy in it.

Public have been facing troubles since when this centre been shifted to a new room located in street.

We would like to request you to investigate this whole matter to maintain transparency in the department and to maintain the name and fame of the corporation otherwise we would be compelled to move forward.

For your kind information the supervisor told us when we went in her contact to know the reason of this shifting of centre then she replied I have made adjustment with the department and no one can harm me and no one can do anything. The supervisor told us Siddarth had suggested me to avail a copy about not taking money from the owner every matter will be vanished.

We hope your kind co-operation in this regard.

Ward no. 27, Asansol-2**

Sir,

We, the undersigned, are the residents of Railpar, Ward no. 27. We had informed you about on RCH centre located in this ward on 13th March 2015 and had made request to investigate the matters involved in conspiracy. We had attracted towards the fact that Ritu Sharma, the supervisor took a sum of Rs 25000/- from the owner of the house and had shared Rs 10000/- with an authority of Health Department Mr Siddharth and had kept Rs 15000/- with herself.

We do not know what happened as after. We have come to know that the owner has given justification about not giving money to the supervisor for this purpose. Then who has given permission to shift the centre from well equipped arrangement to a place where there is lack of facilities. The previous centre was on the main thoroughfare where people from every corner of the ward reached to fulfill their purpose but this new position is at such a place where it is difficult to search.

We would like to say that nobody will accept the donation of money and recipient will not accept also. It is just enough to know about it.

The owner of the house has received his room and is going to set up a zerox machine into this room. That means the owner is using this for business purpose. This is not enough to know this fact.

This room has not even basic facility. On every Wednesday people from different corners and some different wards come to have their child vaccinated but due to this small room and insufficient facility this cannot be done here properly.

We are requesting you to look into this matter and requesting you to investigate this so as to maintain transparency.

We met with local Ex. Councillor but he said that he had not given consent into this.
