A) Due to shortage of HHW in the centres, acute difficulties were being faced by the HHW working in different centres as different government programmes were also being implemented through these HHW in addition to their normal duties. In order to cope with this problem it was decided to fill up the existing (sanctioned) vacancies by engaging HHWs. Two (2) members selection committee consisting of the Mayor and Health Officer, AMC were formed. Notice was published on 07.06.2014 fixing walk-in-interview on 17.06.2014.

On 17.06.2014 walk-in-interview was held in the chamber of Mayor, AMC wherein 38 candidates appeared, out of which 35 candidates were selected. The selected candidates joined 03.07.2014 & 04.07.2014 onwards. Thereafter the selected candidates were asked to undergo training accordingly training were conducted by Dr. Mrs. Jayanti Roy, Dr. A.K.Sen, Dr. D. P. Roy (Gyno) from 4th July 2014 to 21st July 2014.

B) Further, it may be stated here that engagement of Lab Technician cum Store Keeper notice was published in June 2013 fixing date of interview on 31.07.2013. Three (3)-members selection committee consisting Mayor, AMC, CMOH, Asansol Health District & Health Officer, AMC were constituted. After the interview, candidate scoring highest marks was selected and the selected candidate joined on 01.08.2014.




