মহাশয়া,

নদীয়া জেলা তথা পশ্চিমবঙ্গের প্রাচীনতম পৌরসভাগুলির মধ্যে অন্যতম বীরনগর পৌরসভা (যার প্রাচীন নাম উলা)। বহু ইতিহাসের সাক্ষী এই শহরপূর্বে প্রাচীন উলার জনসংখ্যা ছিল ৬০ হাজার, কিন্তু কালান্তক মহামারীর আক্রমণে তা এক হাজারে (১০০০) নেমে আসে। পরবর্তীকালে এই শহরের কীর্তিমান মানুষদের প্রচেষ্টায় ১৮৬১ সালে অস্থায়ীভাবে একটি দাতব্য চিকিৎসালয়ের জন্ম হয়। ১৮৬৯ সাল থেকে সেই চিকিৎসালয়টিই স্থায়ী রূপ লাভ করে এবং তার নামকরণ করা হয় উলা সাধারণ চিকিৎসালয় ও মাতৃসদনা। বীরনগর পৌরসভা পরিচালিত এই হাসপাতালটিই বীরনগর শহরের প্রায় ৩৫,০০০ (পঁয়ত্রিশ হাজার) মানুষ সহ পার্শ্ববর্তী বারাসাত, খিসমা, কালীনারায়নপুর পঞ্চায়েত এলাকার প্রায় দুই লক্ষ (২ লাখ) মানুষের নিকটতম স্বাস্থ্যকেন্দ্র। এইসব এলাকার নিকটবর্তী ১০ কি.মি.র মধ্যে কোন সরকারী হাসপাতাল নেই। বীরনগর পৌরসভা পরিচালিত এই হাসপাতালটি রাজ্য সরকার ও কেন্দ্রীয় সরকার কর্তৃক গৃহীত বিভিন্ন স্বাস্থ্য কর্মসূচী যেমন ডটস্, পালস্ পোলিও, ইউমিনাইজেশন, লেপ্রসি ইত্যাদি দীর্ঘদিন ধরে পালিত হয়। এই এলাকার যে কোন পথ দুর্ঘটনা এমনকি রেল দুর্ঘটনার ক্ষেত্রেও প্রাথমিক পরিষেবা এই হাসপাতাল থাকেই দেওয়া হয়। সরকারী নিয়ম অনুযায়ী পুলিশ যে অভিযুক্ত ব্যক্তিদের গ্রেপ্তার করে তাদের বাধ্যতামূলক স্বাস্থ্যপরীক্ষাও এখানে করানো হয়।

উলা সাধারণ চিকিৎসালয় ও মাতৃসদনের নিজস্ব জমি ও বাড়ী আছে। এখানে ৬ শয্যা বিশিষ্ট মাতৃসদন ও ৬ শয্যা বিশিষ্ট জরুরী বিভাগ, এক্স-রে ও প্যাথলজিক্যাল পরীক্ষা নিরীক্ষার বন্দোবস্ত আছে। এছাড়া এখানে বহির্বিভাগ ও অ্যাম্বুলেন্স পরিষেবার ব্যবস্থা আছে।

পৌরসভা পরিচালিত এই হাসপাতালটি বাম আমল থেকে সরকারী সহযোগিতা থেকে সম্পূর্ণভাবে বঞ্চিত। বারংবার সরকারের দৃষ্টি আকর্ষণ করা স্বত্বেও কোন সুরাহা হয়নি। সরকারের পক্ষ থেকে কোন প্রশিক্ষণপ্রাপ্ত নার্স পাওয়া যায়নি, সরকারী আর্থিক অনুদান যা হাসপাতাল আগে পেত তাও বাম আমল থেকে বন্ধ।

এমতাবস্থায় শতাধিক বছরের পুরানো এই হাসপাতালটি যে কোন সময় বন্ধ হয়ে যেতে পারে। সে ক্ষেত্রে বীরনগর শহর ও পার্শ্ববর্তী পঞ্চায়েত এলাকার প্রায় দুই লক্ষ (২ লাখ) মানুষ সমূহ বিপদের মধ্যে পড়বেন।

To summarize :

- Decision of the Department may be sort as to whether release of fund be allowed in case of renovation of sub center in hired accommodation.
- For sub center and maternity home it is suggested that the Chairman may be requested to submit plan, drawing and design including cost estimate as per PWD Schedule, vetted by MED.
- For procurement of furniture & equipment, it is suggested to obtain item wise technical specification and approved cost from Health & FW Department.
- ILR could not be procured from open market as it is supplied centrally by DHFW.
- Decision of the Department may be obtained with regard to procurement of some equipment for MH like Generator, Digital X-RAY, USG and ECG machine.

From the communications of the Chairman, it is revealed that one charitable dispensary started functioning in the year 1861. In the year 1869 the said dispensary is named as "Ula General Hospital & Maternity Home" and caters for two lakh population including that of adjoining areas.

The said maternity home is having six bed for delivery, six bed for emergency accidental cases including railway accidents, X-RAY department, pathology, outdoor clinic and ambulance services. Besides these the other services i.e. DOTs, Pulse Polio, routine Immunization, Leprosy control are being provided.

Available man power in permanent posts are as under :

- Medical Officer - 3 nos.
- Radiologist - 1 no.
- Pathologist - 1 no.
- Trained nurse - 4 nos.
- Ambulance Drivers - 2 nos.
- Ambulance Assistant - 2 nos.

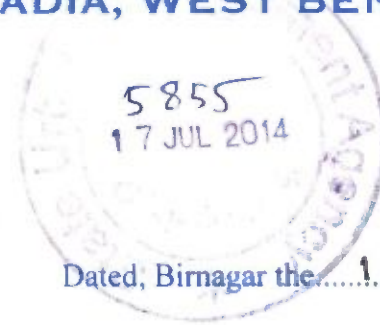

Upto 1978 the Board of Commissioners provided Doctors, Nurses, Attendants etc posts were created and appointed for smoothly running of this Unit till all those staff were retired. Since then we are trying our best to run the said old age Matri Sadan from the available staff of the Municipality. Of late one Post of Doctor has been sanctioned by the Govt. and a Medical Officer has now been posted there. The filling up the rest posts are not possible as because the Staff Pattern adopted for this Municipality in 1995 ignored our demand for consideration of creation of posts for the Matri Sadan. The pressure is mounting day by day of inhabitants seeking first aid, health check up and check up of pregnant mothers(as numbers of poor in this locality is very large who do not have the capacity to visit Krishnagar Hospital or Ranaghat Hospital of their own).

In view of this scenario, I would fervently request your good self to consider of creating at least one Medical Officer more, General Nurse 2, General Duty Staff-2, Aya-2, Guard-1 and Sweeper-1 for proper and smooth functioning of the said Matri Sadan.

We would also plea before you to provide fund to the tune of Rs Two lakh per annum for purchase of medicine, disinfectant, bandages, cotton wools etc for catering free of cost to the poor residents of this Municipality which we used to get in earlier times (though the amount was Rs. 50,000/- per annum). All these are required in the interest of the public service.

We shall remain ever grateful to you if you help this Municipality in achieving the same as prayed for.

- The names of regular candidates (Fourteen nos.) only is to be listed and put up in the notice board of ULB, asking them to function as HHW with effect from 25th June, 2007 and inform Director, SUDA accordingly with regard to date of joining of HHWs.
- The Chairman of the ULB is to allocate the area of operation for each HHW.
- One HHW will cover a population not exceeding 1,000 BPL contained in a single ward. A ward having less than 1,000 BPL population will have one HHW.
- The HHW shall be responsible for Primary Health Care of BPL families under her jurisdiction and be responsible for both public health and health statistical data collection for the entire population within the ward.
- The ward Councillor will monitor and supervise the activity at ward level.
- HHW Kit bag along with contents provided by SUDA is to be given to all the regular HHWs only.
- To start with, HHW will conduct baseline survey of the allotted BPL families as per the proforma already provided by SUDA, to be checked and scrutinized by HO / MO / SI, who will compile the data ward-wise and ULB-wise.
- Job responsibility of the HHW (working hours 12-00 Noon to 4-00 P.M. of each working day) is :
 - fortnightly home visit to each BPL families,
 - motivate the community to avail health services – collection of data and filling up of Family Schedule,
 - treatment of minor ailments at door step, distribution of drugs for three days maximum,
 - registration of pregnancy within 12 weeks,
 - identification of danger signs of pregnancy and its referral,
 - act as depot holder of ORS, Nirodh, OCP, Iron Folic Acid tablet etc.,
 - counselling on child nutrition and immunization,

- counselling adolescents for physical, psychological and nutritional growth,

- As per Project proposal, the service charge (rental) should not exceed Rs. 1,000/- per month per Sub-Centre which includes electricity, water & sweeping / cleaning charges. These rental charges will only be applicable for the Sub-Centre accommodated in Club / CBO accommodation. There will be no rental charges for the Sub-Centre accommodated in municipal / community accommodation.

We also like to give it to your knowledge that there is no Govt. Hospital within the 5 miles radius of Birnagar Municipality.


Keeping in view, C.M.O(H), Nadia recommended to increase the grant-in-aid but till date no action has been taken in the matter.
