Enclosed opposite communication of Chairman, Chakdah Municipality for clarification regarding pay fixation of Health officer. Incidentally, it is noticed that this requirement is for payment to Dr. Chanchal Majumder, who have resigned from service in last Nov, 2012. It is also to be noted that we have already released fund by taking D.A rate @ 103% w.e.f 01.04.2012 to all municipalities including Chakdah Municipality.

Enclosed opposite memo no. 846/MA/C-10/3S-55/2005 Pt. I dt. 08.08.2008 wherein it was iterated that Health Officer engaged under CBPHC scheme will get 8,000/- as basic salary plus 50% dearness pay and admissible D.A rate prevailing on date of engagement and/or date of renewal. The total amount will be fixed for 1 year subject to last date of completion of project period. There will be no change of pay in the interim period for enhancement of D.A rate announced by Government for personnel getting salary under unrevised pay scale.

An order vide no. 146/MA/N/C-2/1G-10/2005 dt 23.12.2011 was released by Dept of MA wherein it was written that the rate of D.A will be @ 103% w.e.f 01.01.2012. Simultaneously, we have informed all municipalities to follow the guidelines as given in 8451/MA/C-10/3S-55/2005 dt 22.04.2008 and 846/MA/C-10/3S-55/2005 dt. 08.08.2008 wherein it is notwd that rate of D.A will be changed at the date of Contractual engagement of respective Health Officers engaged at different ULBs. As the order no 146/MA/N/C-2/1G-10/2005 is saying about the rate of D.A, we have followed the amount of D.A rate for fixing the total contractual remuneration of H.O engaged under CBPHCS.

In this connection we may write to Chairman, Chakdah Municipality about the rate of D.A i.e 103% so that he may release the arrear payment to Dr. Chanchal Majumder, erstwhile H.O of Chakdah Municipality.

In terms of order no 846/HA/C-10/3S-55/2005 Pt. I dated 8.08.2008 on engagement of Health officer under CBPHCS the Health officer are entitled to get time to time admissible D.A. But the enhancement of contractual remuneration on account of D.A. would be given effect once in a year i.e. normally the date of renewal of the contract. (Flg 4)

In compliance with the <sup>aforsaid</sup> order read with order for D.A. it has been revealed the Health officer posted in Chakdah Municipality is entitled to get 103% D.A. on basic. <sup>in unrevised pay scale</sup> Keeping in mind the orders SUDA (Health) has also released the fund accordingly.

Sub. : Requirement of addl. HHWs under CBPHCS at Chakdah Municipality

Placed herewith communication of the Chairman, Chakdah Municipality bearing no. 262/CM dt. 04.03.2009 requesting for sanction of addl. HHWs under CBPHCS.

It may be seen from his communication that there are 20 HHWs existing against 20 wards of Chakdah Municipality when the CBPHCS Programme was sanctioned. Presently, one more ward has been added resulting in 21 wards instead of 20 and the Municipality has been declared as "C" category Municipality.

As per principle of CBPHCS and Urban Health Strategy each ward should have one HHW. Hence, the ULB may be allowed to engage one HHW from the existing panel candidates after ensuing Parliament Election is over.

As per recent BPL survey at Chakdah Municipality, the no. of BPL families 4646 and the BPL population 21877. There are few more ULBs who have submitted the same proposal. In this regard, policy decision may be taken in a separate file which will be submitted later on.
