

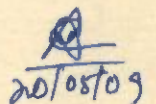

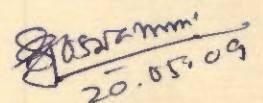
Special Secretary, Dept. of Municipal Affairs verbally instructed Sri Sankar Banerjee, Staff of ILGUS to hire one A.C. Innova car on emergency basis. A car no. WB 23A - 1382 was hired and utilized by Additional Secretary, Ministry of Health & Family Welfare, GOI on 26th & 27th Feb, 2009.

As the vehicle was hired on casual/emergency basis, the owner of car did not agree to rent out the car at the govt rate which is Rs 135/hour or Rs 16.00/Km. After utilization of car, M/s B.J. Dhar submitted a bill for an amount of Rs 4775.00 which is in excess of Rs 996.20 $\left[\frac{1}{2} (9.25 \times 135) + (147 \times Rs 16) \right]$

per Govt. rate. The certificate is being endorsed in the back side of bill no. 436/08-09 dt. 24/02/09 by Sri Sankar Banerjee & counter signed by Special Case, the bill submitted by M/s B.J. Dhar may be approved & sanctioned.
