

Sub. : Selection of HHW under IPP-VIII.

Placed herewith communication of the Chairman, South Dum Dum Municipality bearing no. SDDM/Health/148/10-11 dt. 13.05.2010 with regard to selection of HHWs to fill up the existing vacancy.

This is to mention here that IPP-VIII was implemented in South Dum Dum Municipality in the year 1992-93 wherein the approved no. of HHWs was 194. The ULB is having 35 wards. Ward-wise BPL population total is 16,153 according to latest Household Survey, 2006. As per Urban Health Strategy, 2008, the required no. of HHWs is 37, whereas the existing no. of HHWs is 194.

In the mean time, a no. of ULBs communicated to SUDA regarding filling up of vacancy for the post of HHW, the policy matter in this regard is to be decided by the Department whether the existing vacancy for HHW would be filled up in spite of having excess no. of HHWs as per Urban Health Strategy. This matter was placed through Note Sheet on 10.11.2009, followed by two reminder letters dt. 16.01.2010 & 16.03.2010 addressed to the Secretary, Dept. of MA. We are yet to receive decision of the Department.

For the instant case of South Dum Dum Municipality we may forward the letter to the Department to communicate their decision in the matter at the earliest.
