Further to this office 2nd communication to the Secretary, Urban Health, DHFW vide no. SUDA-Health/532/09/249 dt. 04.10.2010 on the subject of sanction for Puja Bonus to the Health functionaries of CBPHCS and HHW Scheme of 74 ULBs, this is to inform you that FO, Health, SUDA and the undersigned repeatedly pursued the matter with DHFW either meeting with them at Swasthya Bhavan or over telephone. FO, Health even visited office of DHFW on date twice at 11.30 a.m. and 2.30 p.m. It is gathered that DHFW is not in a position to issue sanction letter in connection with Puja Bonus.

This is a very pitiful condition as also sensitive issue wherein Health functionaries of 52 ULBs implementing Urban Health Programmes other than CBPHCS and HHW Scheme have already received Puja Bonus and that of 74 ULBs implementing CBPHCS and HHW Scheme have been deprived of getting the said benefit in spite of doing similar nature of job.

This is also to inform you that the matter on grant of Puja Bonus was discussed in the meeting of Hon'ble MIC, Health and Hon'ble MIC, MA & UD held at Swasthya Bhawan on 23.09.2010 wherein negative response had not been observed.

The concerned 74 ULBs time and again are enquiring about issuance of order for grant of Puja Bonus and pressing hard for release of the same before Puja.

Should this issue be taken up by the Dept. of MA with DHFW to sort out the matter ?
