National Rural Health Mission -এর আর্থিক দক্ষিণে প্রতিপালিত প: ব: সরকারের রাজ্য নগরোন্নয়ন দপ্তরের স্বাস্থ্য প্রকল্পে আমরা প: বঙ্গের বিভিন্ন পৌরসভা সমূহে স্বাস্থ্যকর্মী হিসাবে বিগত ২০০৪ সাল থেকে অস্থায়ী ঠিকা শ্রেণীতে কর্মরত আছি।

রাজ্যের বিভিন্ন পৌর এলাকার দারিদ্র্য সীমার নীচে বসবাসকারী মানুষদের - বিশেষত: - বস্তি এলাকা, অনুন্নত প্রান্তিক শ্রেণী, তপশীলি জাতি ও উপজাতি সম্প্রদায়, হরিজন পল্লী, আদিবাসী সাঁওতালি, ওঁরাও অধ্যুষিত পল্লী ও সংখ্যালঘু শ্রেণীভুক্ত মানুষদের বাড়ি বাড়ি ঘুরে আমরা স্বাস্থ্য পরিষেবা দিই।

প্রতিটি পৌরসভাতেই আমরা ১০০০ পরিবার পিছু একটি করে উপ-স্বাস্থ্যকেন্দ্র গড়ে তুলে সেখানে একদিন করে - গর্ভবতী মহিলাদের চিকিৎসা, নবজাতক শিশুদের চিকিৎসা, ০-৫ বছর বয়সী বাচ্চাদের নিয়মিত ওজন নেওয়া, ০-৫ বয়সী বাচ্চাদের টীকাকরণ করা, সচেতনতামূলক আলোচনার আয়োজন করা ও সব রকম পরামর্শ দেওয়া এবং দারিদ্র্য সীমার নীচে বসবাসকারী মানুষদের জন্যই প্রধানত: বিনামূল্যে চিকিৎসক দ্বারা চিকিৎসা ও ঔষধ দেওয়া হয়। এই সমস্ত উপ-স্বাস্থ্যকেন্দ্রগুলিতে আমরা সমস্ত স্বাস্থ্যকর্মী ও চিকিৎসক মিলে একটি পরিবারের মতো ঐক্যবদ্ধ হয়ে সাধারণ গরীব মানুষদের পরিষেবা দেওয়ার কাজটি করি।

আমাদের বৈশিষ্ট্য :-

১. চিকিৎসক ও স্বাস্থ্যকর্মীগণ নিয়মিত সঠিক সময়ে উপ-স্বাস্থ্যকেন্দ্রের দায়িত্ব পালন করেন।
২. রোগীরা চিকিৎসক ও স্বাস্থ্যকর্মীদের সাথে কোন দালাল ছাড়াই সরাসরি মিশতে পারেন ও পরিষেবা পান।
৩. উপ-স্বাস্থ্যকেন্দ্র তথা এই প্রকল্পটি সম্পূর্ণ দূনীতি মুক্ত।

আমাদের আবেদন :-

১. **পরিকাঠামোগত সমস্যা ও তার উন্নয়ন :-** পৌর এলাকায় স্বাস্থ্য পরিষেবা দেওয়ার জন্য, যে গ্রামীণ স্বাস্থ্যকেন্দ্রগুলি আছে তার পরিষেবা গ্রামের মানুষের চাহিদার তুলনায় এতই কম যে, বহু রোগী স্বাস্থ্যকেন্দ্র থেকে ঠিকমতো চিকিৎসা পান না। এইসব এলাকার সাধারণ গরীব বা মধ্যবিত্ত শ্রেণী অন্য কোথাও বেশী অর্থ দিয়ে চিকিৎসা করাতেও পারেন না, ফলে এলাকার বহু রোগী, গর্ভবতী মহিলা, শিশু চিকিৎসার অভাবে দিনের পর দিন কষ্ট পেতে থাকে, আবার অনেকে বিনা চিকিৎসায়, বিনা ঔষুধে, এমনকি রোগের কারণ জানতে না পেরেই মারা যায়। গ্রামীণ স্বাস্থ্য মিশনের আওতায় গ্রামগুলিতে স্বাস্থ্যদপ্তর উপ-স্বাস্থ্যকেন্দ্র গড়ে তুললেও পৌর এলাকাগুলি অবহেলিত হয়েই আছে।

তাই আমাদের আবেদন, আমরা এই C.B.P.H.C.S বা D.F.I.D. -এই ধরনের প্রকল্পে উপ-স্বাস্থ্যকেন্দ্রগুলি গড়ে তুলে যেভাবে কাজ করছি সেই কাজের ধরণটিকে আরো উন্নত করা হোক। উপ-স্বাস্থ্যকেন্দ্রগুলির সঙ্গে সঙ্গেই পৌরসভাস্তরে একটি করে হাসপাতাল গড়ে তোলা হোক যেখানে ২৪ ঘন্টা সূষ্ঠ ও সুন্দরভাবে স্বাস্থ্য পরিষেবা দেওয়ার কাজ চলবে এবং যেখানে সাধারণ মানুষ অত্যাধুনিক চিকিৎসার সুযোগ পাবে। যাতে করে এলাকায় শিশু মৃত্যু ও মাতৃ মৃত্যু রোধ করা যাবে। একই সঙ্গে বলে রাখা ভালো যে বর্তমান প্রকল্পে আমরা শুধু দারিদ্র্যসীমার নীচে বসবাসকারী মানুষদের জন্য কাজ করছি, কিন্তু বাস্তবে আমরা দেখতে পাই উপ-স্বাস্থ্যকেন্দ্রগুলিতে সব ধরনের মানুষই পরিষেবা নিতে আসেন, এবং তাঁরা চান আমরা যেন বাড়ী বাড়ী ঘুরে সকলকেই এই পরিষেবা দিই। তাই এই প্রকল্পে সকলের জন্য পরিষেবার ব্যবস্থা হলে এলাকার সকল মানুষই উপকৃত হন।

২. **কর্মীদের যথাযথ প্রশিক্ষণ ও উপযুক্ত কাজের পরিবাশ তৈরী করা :-** আমাদের বিনীত আবেদন, আমাদের প্রথম সারির পরিদর্শিকাদের স্বাস্থ্য দপ্তরের ANM (R) -শ্রেণীর স্বাস্থ্যকর্মীদের মতো সুপ্রশিক্ষণের মাধ্যমে তাদেরকে আরো যোগ্য করে গড়ে তুললে আমাদের পরিষেবা আরো সুন্দর হবে ও সার্থক হবে। একই সঙ্গে স্বাস্থ্যকর্মীদের জন্যও আরও উন্নত পরিষেবা দিতে পারে। যে সমস্ত পৌরসভার নিজস্ব হাসপাতাল আছে, সেখানে বা অন্য কোনো স্থানীয় হাসপাতালে স্বাস্থ্যকর্মী ও পরিদর্শিকাদের পর্যায়ক্রমে পর্যবেক্ষণ ও প্রশিক্ষণের ব্যবস্থা করা হলে এলাকার সাধারণ দরিদ্র মানুষ এইসব ট্রেনিং প্রাপ্ত মহিলা স্বাস্থ্যকর্মীর দ্বারা অল্প হলেও উপকৃত হবেন।

৩. কর্মীদের বেতন কাঠামোর স্বল্পতা ও পুনর্বিন্যাস :- পৌরসভার স্বেচ্ছাসেবী স্বাস্থ্যকর্মী প্রকল্পে যে সমস্ত কর্মী কাজ করে তাঁদের বর্তমান কাঠামো আপনাদের সামনে তুলে ধরা হল -

(ক) মহিলা স্বাস্থ্যকর্মী	-	২,০০০/- টাকা
(খ) প্রথম সারির পরিদর্শিকা	-	২,১৭০/- টাকা
(গ) অফিস কর্মী	-	৫,০০০/- টাকা
(ঘ) ডেভলপমেন্ট অফিসার	-	৮,০০০/- টাকা

National Rural Health Mission -এর আর্থিক দক্ষিণে প্রতিপালিত প: ব: সরকারের রাজ্য নগরোন্নয়ন দপ্তরের স্বাস্থ্য প্রকল্পে আমরা প: বঙ্গের বিভিন্ন পৌরসভা সমূহে স্বাস্থ্যকর্মী হিসাবে বিগত ২০০৪ সাল থেকে অস্থায়ী ঠিকা শ্রেণীতে কর্মরত আছি।

রাজ্যের বিভিন্ন পৌর এলাকার দারিদ্র্য সীমার নীচে বসবাসকারী মানুষদের - বিশেষত: - বস্তি এলাকা, অনুন্নত প্রান্তিক শ্রেণী, তপশীলি জাতি ও উপজাতি সম্প্রদায়, হরিজন পল্লী, আদিবাসী সাঁওতালি, ওঁরাও অধ্যুষিত পল্লী ও সংখ্যালঘু শ্রেণীভুক্ত মানুষদের বাড়ি বাড়ি ঘুরে আমরা স্বাস্থ্য পরিষেবা দিই।

প্রতিটি পৌরসভাতেই আমরা ১০০০ পরিবার পিছু একটি করে উপ-স্বাস্থ্যকেন্দ্র গড়ে তুলে সেখানে একদিন করে - গর্ভবতী মহিলাদের চিকিৎসা, নবজাতক শিশুদের চিকিৎসা, ০-৫ বছর বয়সী বাচ্চাদের নিয়মিত ওজন নেওয়া, ০-৫ বয়সী বাচ্চাদের টীকাকরণ করা, সচেতনতামূলক আলোচনার আয়োজন করা ও সব রকম পরামর্শ দেওয়া এবং দারিদ্র্য সীমার নীচে বসবাসকারী মানুষদের জন্যই প্রধানত: বিনামূল্যে চিকিৎসক দ্বারা চিকিৎসা ও ঔষধ দেওয়া হয়। এই সমস্ত উপ-স্বাস্থ্যকেন্দ্রগুলিতে আমরা সমস্ত স্বাস্থ্যকর্মী ও চিকিৎসক মিলে একটি পরিবারের মতো ঐক্যবদ্ধ হয়ে সাধারণ গরিব মানুষদের পরিষেবা দেওয়ার কাজটি করি।

আমাদের বৈশিষ্ট্য :-

১. চিকিৎসক ও স্বাস্থ্যকর্মীগণ নিয়মিত সঠিক সময়ে উপ-স্বাস্থ্যকেন্দ্রের দায়িত্ব পালন করেন।
২. রোগীরা চিকিৎসক ও স্বাস্থ্যকর্মীদের সাথে কোন দালাল ছাড়াই সরাসরি মিশিতে পারেন ও পরিষেবা পান।
৩. উপ-স্বাস্থ্যকেন্দ্র তথা এই প্রকল্পটি সম্পূর্ণ দূনীতি মুক্ত।

আমাদের আবেদন :-

১. পরিকাঠামোগত সমস্যা ও তার উন্নয়ন :- পৌর এলাকায় স্বাস্থ্য পরিষেবা দেওয়ার জন্য, যে গ্রামীণ স্বাস্থ্যকেন্দ্রগুলি আছে তার পরিষেবা গ্রামের মানুষের চাহিদার তুলনায় এতই কম যে, বহু রোগী স্বাস্থ্যকেন্দ্র থেকে ঠিকমতো চিকিৎসা পান না। এইসব এলাকার সাধারণ গরিব বা মধ্যবিত্ত শ্রেণী অন্য কোথাও বেশী অর্থ দিয়ে চিকিৎসা করতেও পারেন না, ফলে এলাকার বহু রোগী, গর্ভবতী মহিলা, শিশু চিকিৎসার অভাবে দিনের পর দিন কষ্ট পেতে থাকে, আবার অনেকে বিনা চিকিৎসায়, বিনা ঔষুধে, এমনকি রোগের কারণ জানতে না পেয়েই মারা যায়। গ্রামীণ স্বাস্থ্য মিশনের আওতায় গ্রামগুলিতে স্বাস্থ্যদপ্তর উপ-স্বাস্থ্যকেন্দ্র গড়ে তুললেও পৌর এলাকাগুলি অবহেলিত হয়েই আছে।

তাই আমাদের আবেদন, আমরা এই C.B.P.H.C.S বা D.F.I.D. -এই ধরনের প্রকল্পে উপ-স্বাস্থ্যকেন্দ্রগুলি গড়ে তুলে যেভাবে কাজ করছি সেই কাজের ধরণটিকে আরো উন্নত করা হোক। উপ-স্বাস্থ্যকেন্দ্রগুলির সঙ্গে সঙ্গেই পৌরসভাস্তরে একটি করে হাসপাতাল গড়ে তোলা হোক যেখানে ২৪ ঘন্টা সূষ্ঠ ও সুন্দরভাবে স্বাস্থ্য পরিষেবা দেওয়ার কাজ চলবে এবং যেখানে সাধারণ মানুষ অত্যাধুনিক চিকিৎসার সুযোগ পাবে। যাতে করে এলাকায় শিশু মৃত্যু ও মাতৃ মৃত্যু রোধ করা যাবে। একই সঙ্গে বলে রাখা ভালো যে বর্তমান প্রকল্পে আমরা শুধু দারিদ্র্যসীমার নীচে বসবাসকারী মানুষদের জন্য কাজ করছি, কিন্তু বাস্তবে আমরা দেখতে পাই উপ-স্বাস্থ্যকেন্দ্রগুলিতে সব ধরনের মানুষই পরিষেবা নিতে আসেন, এবং তাঁরা চান আমরা যেন বাড়ী বাড়ী ঘুরে সকলকেই এই পরিষেবা দিই। তাই এই প্রকল্পে সকলের জন্য পরিষেবার ব্যবস্থা হলে এলাকার সকল মানুষই উপকৃত হন।





Sir,

With due regards & humble submission I am to place some salient and rational points before you for kind perusal and cordial consideration as regards enhancement of consolidated (fixed) pay of the Medical Officer & Staff of C.B.P.H.C.S. under this Municipality, in comparison to their services offered to the public at large.

Services offered by them are :-

A) C.B.P.H.C.S. :

- i) General Treatment for the members of B.P.L families and members of economically backward classes.
- ii) Immunization (Expectant mothers and children).
- iii) ANC & PNC check-up and counselling of Family Planning.
- iv) Awareness Programme for Public Health & Sanitation.
- v) Growth Monitoring Programme.
- vi) National Programme (e.g. Pulse-Polio, Filaria, AIDS etc.)

B) School Health Programme under KUSP.

C) Janani Suraksha Yojana.

The performance rendered by them are very satisfactory and in a word the public are very much pleased with their services but they are ill-paid in these hard days, when a Gr.-'C' employee of W.B. Govt. is initially drawing Rs. more than 13,000/- (Thirteen thousand) only, where our Medical Officer (MBBS) is paid only Rs. 6,750/- and other staff are drawing less than Rs. 6,500/- or Rs. 6,000/- which is also meagre in comparison to the salary of a Gr.- 'D' staff of State Govt.

I realise their practical problems but without your kind approval and placement of fund, I am not in a position to do anything for them. But it is a matter of deep phobia for us if the doctor and staff leave their job which may cause total collapse of the Health Services of this Municipality. The health service of this Municipality pays an important role and in no circumstances it can be stopped considering the gravity of Health Awareness, Family Planning, General Treatment & Immunization, Awareness & Care for the ANC & PNC etc.

So, it would be better for Municipality as well as the staff of C.B.P.H.C.S. if the existing permanent Health Sector (which played tremendous role in the past, though at present with skeleton staff) is merged with the wing of C.B.P.H.C.S. and thus the burning problem may be solved with a hope of light.

Therefore, you are fervently requested to think over the matter sympathetically so that our Health Services can run smoothly without any interruption and feeling of insecurity among the staff of C.B.P.H.C.S. is disappeared.

Placed herewith prayer dt. 07.12.2009 of Health functionaries of the ULBs implementing CBPHCS and HHW Scheme.

The prayer is with regard to –

- (i) Health infrastructure (Sub-Centre) improvement including establishment of Hospital,
- (ii) Training to Health functionaries in particular training of First Tier Supervisors at par with training of ANM course imparted by DHFW,
- (iii) Enhancement of Honorarium / Salaries to different categories of Health functionaries.

In respect of prayer no. 1, this is to state that Sub-Centres are accommodated at either ULB or Club or School premises. There is no fund provision for construction of Sub-Centres for the present both at CBPHCS & HHW Scheme. Though there was fund provision for repair & renovation for Sub-Centres initially under CBPHCS but due to constraint of fund flow this issue is not being addressed. With regard to establishment of Hospital at ULB level, this is to state that as per Urban Health Strategy, 2008, referral system is to be established with nearest existing Govt. Health facilities i.e. Rural Hospital / BPHC / PHC / SD / District Hospital.

In respect of prayer no. 2, this is to mention that ANM course for 18 months is conducted by DHFW and there is specific criteria for selection of ANM. However, retraining on Health issues on which they are actually working, are being imparted time to time. Moreover, Routine Immunisation training for 25 days at Nursing Training School of the Districts are in progress where 704 no. of FTSs out of 1473 had already been trained; rest are in pipe line.

In respect of prayer no. 3 towards enhancement of honorarium / remuneration, the file has already been mooted and submitted vide no. SUDA-Health/533/09 dt. 27.11.2009.

I would like to draw your kind attention to the discrimination faced by the personnel engaged in our DFID - Assisted Honorary Health Workers Scheme (HHW Scheme) in regarding their pay hike.

This HHW Scheme was initiated in 11 municipalities of West Bengal outside KMDA area with an approval by the Government of India vide their letter no. L - 19012 / 46 / 02 dated 02. 12. 2003 and was also accorded by the Govt. of west Bengal.

Since then the scheme has been implemented and monitored by the Central Coordinating Cell at State Urban Development Agency (SUDA).

But since its inception in 2004 and after completing 05 successful years of health service to the poor people of the urban area, their service has become quiet indispensable for the slum dwellers, little was done for the welfare of the personnel engaged under this scheme.

There was only a meager pay hike; even in case of some post the enhancement is only around 10 % in last 05 years.

Now, in the light of Pay Commission 2009 and economic recession, they surely need a better pay package.

I fervently request you to take this matter with utmost priority.

With due respect, we would like to inform you that we are, the health staffs under NRHM (CBPHCS) in your Municipality and have been discharging our duties faithfully and with your entire satisfaction.

In this context we beg to inform you that we have been performing our duties since 2008 and our contractual monthly remuneration is noted below including our enhanced monthly remuneration w.e.f. 01-02-2009.

But it appears from the copy of G.O. No. HFW/NRHM/18/06/329 ; dated 15-06-09 that the monthly contractual remuneration of the Block Data Entry Operator under NRHM has been raised from Rs. 5000/- to Rs. 8840/- w.e.f. 01-04-09 and monthly remuneration of the Block Account Manager from Rs. 8000/- to Rs. 11040/-, the copy of the said G.O. is enclosed for your kind perusal and special consideration.

Now, we would like to draw your kind attention that we, being the poor paid employees are being deprived from the monthly contractual remuneration from 01-04-08 and we are getting at least Rs. 3000/- less per month than the Block Level staff working under NRHM.

Besides this, there is another fact i.e. before commencement of pay commission a regular group-'C' staff in your Municipality was paid Rs. 7035 p/m. Where as we were paid according to designation as mentioned above. But after commencement of pay commission, a regular group C staff is now paid Rs 12,000/- p/m. Where as we are paid with out any increment.

As a result we are now the victim of disparity in your Municipality and even getting less monthly contractual remuneration than the Block Level Health Staff under NRHM as mentioned above.

It is our earnest request to you that please take necessary steps, so that we can get the enhanced monthly remuneration with effect from 01-04-2009 as mentioned above & we are n't deprived of our legitimate demands.
