Issues on Health were discussed in the meeting held at the chamber of Special Officer and Ex-officio Asstt. Secretary, Department of Municipal Affairs on 05.07.2011 at 4.00 p.m. The decision arrived at the said meeting is enclosed at **Flag - A**.

It may be seen that the issue on rationalization of nomenclature of personnel engaged appearing at serial no. 1-(d) of Flag - A was discussed and it was decided that a fresh proposal is to be submitted by SUDA.

This is to state that CUDP III, CSIP & IPP-VIII have been brought under one umbrella of SUDA w.e.f. 01.04.2008 - the records relating to sanctioned no. ^{2 category} of posts, engagement of manpower to the said post, approved Honorarium / Salaries are not available with SUDA. However, the records obtained from the requisition of fund submitted by the ULBs and a few available records of KMDA has been taken into account while preparing project-wise category of post along with their remuneration (**enclosed at Flag - B**). It may be seen that only two posts appearing at serial no. 4 & 5 of Flag - B require renaming/*redesignation*.

This is also to state that only rationalization of nomenclature of personnel may be clubbed with restructuring of Health Programmes wherever required. Facility-wise sanctioned post varies in each of the five Health Programmes in O & M Phase. As the Health facilities were set up with the objective of delivering the same type of services, discrepancy in sanctioned post would not yield the same service out.

However, the category of existing post along with present Honorarium / Salary at Flag - B may be sent to the Department as was decided in the meeting held on 05.07.2011.
