As instructed the notes prepared by the undersigned as above may please be placed before the ensuing Governing Body's meeting for ratification with effect from October, 1998, for RCH, Asansol and December, 1998 for IPP-VIII Extension."

Accordingly, the same is being placed with G.B. for ratification.

In this connection, it is suggested that the separate Bank Account that is being maintained for IPP - VIII Extension and RCH, Asansol in Central Bank may be operated by the Health Sector. The signatories in cheques may be Adviser (Health) and Special Secretary, M.A. Department as against the present procedure of Director & C.E., SUDA and Special Secretary. All payments related to Health Sector including establishment matters will be made by Adviser (Health). This will help in operating the Health Sector independently. Health Sector should maintain a separate account which is necessary for keeping proper control on accounts of RCH, Asansol and IPP-VIII Extension. In this connection, it is brought to the notice of G.B. that the total expenditure of Health Sector in SUDA is chargeable to RCH, Asansol and IPP - VIII Extension. Health Sector will keep its own cash book and accounts separately and act independent of SUDA accounts. All necessary reports to be submitted to internal and external agencies and also to audit has to be prepared by the Health Sector. A separate internal audit for Health Sector may also be arranged.

After cessation of external funding support, the Urban Health Programmes appearing at serial no. 1 to 5 in the table at pre-page are continued and maintained by the Dept. of Municipal Affairs, GOWB.

This is also to mention that Health facilities & category of Health manpower sanctioned for the different projects are varying in nature. All the Health Programmes have been brought under one umbrella at SUDA for implementation, monitoring and supervision since 01.04.2008. As the activities of the above mentioned Health programme are similar in nature, uniform approach may be adopted for five nos. of Health Programmes which are in O & M phase. This issue of restructuring was kept in the work plan of FY 2007-08 under Health component of KUSP for strengthening existing Health services. Dept. of Municipal Affairs agreed in principle (i) restructuring of Health programme should be a comprehensive one under single name for the programme (ii) obtaining clearance from Finance Dept. for budgeting all budget head under MA Dept. under one broad Health set up (vide copy of NS-6 marked "X" at Flag - A).

Hence the following measures may be adopted for restructuring of Urban Health Programmes:

- The unified Health programmes may be termed as "Community Based Urban Health Services" in place of different names i.e. CUDP III, IPP-VIII, CSIP, IPP-VIII (Extn.) and RCH Sub-Project, Asansol notification be issued by the Department of Municipal Affairs.
- Single budgetary source and funding from Finance Dept. in respect of "Community Based Urban Health Services".
- ULB-wise maintenances of single A/C by the ULB for the Urban Health Programmes notification be issued by the Department of Municipal Affairs.
- Rationalisation of nomenclature of personnel engaged under different Health Programmes. Existing as well as required manpower under different Health Programmes and proposed restructuring wherever required is enclosed at Flag B.
- Existing manpower and their present & proposed remuneration is enclosed at Flag C.

You are requested to take further necessary action for restructuring of Urban Health Programmes as mentioned above, to maintain uniformity relating to Health service delivery effectively to the population.
