To minimize confusion (if any) at the end of the ULB communication may be made separately for KMC, Municipal Corporation implementing both CUDP III and IPP-VIII, Municipalities implementing both CUDP III and IPP-VIII, Municipalities implementing only IPP-VIII, Municipality implementing only CUDP III, Municipal Corporation implementing IPP-VIII (Extn.) and RCH Sub-Project and Municipalities implementing IPP-VIII (Extn.).

This is to mention here that SUDA Health Wing is maintaining two (02) current accounts namely IPP-VIII (Extn.) O & M, SUDA bearing no. 1537964923 for the then Health Programmes namely IPP-VIII, IPP-VIII (Extn.), CUDP III & CSIP and RCH, Asansol O & M, SUDA bearing no. 1537964876 for RCH Sub-Project, Asansol, to deal with receipt of funds from Department of Municipal Affairs through Director, SUDA and onward release to 52 ULBs.

Now, it is necessary to open a new account in the name of "Urban Primary Health Care Services, SUDA" to receive fund since the period April, 2012 from the Department of Municipal Affairs. The new account will jointly be operated by Project Officer, Health, SUDA and Finance Officer, Health, SUDA as is prevailing in the above mentioned existing current accounts.

It is gathered that the Department will release fund for the period April to July, 2012 shortly for onward release to the respective ULBs.

It is proposed that the existing current accounts may be closed after AG Auditing.
