## A Status Report on National Urban Health Mission (NUHM) w.r.t. meeting of the Principal Secretary, UD & MA Dept. on 22,11,2018

National Urban Health Mission (NUHM) is a centrally sponsored Scheme implemented in 89 ULBs in phases, covering 2.02 Crore population to improve the Health status of the Urban population with special focus on Urban poor living in slums and all other vulnerable population.

In West Bengal, activity under National Urban Health Mission has been initiated as per approved state PIP since February, 2014 to strength the primary Health care delivery system in Urban area. For effective implementation of the Programme, Department of Health & Family Welfare, Govt. of West Bengal in consultation with UD & MA Department has finalized modalities regarding implementation strategy, fund flow to the ULBs, formation of city Urban Health society for all the Municipal Corporation, procurement of drugs & equipments, new construction of Urban Primary Health Centre, repair & renovation of the existing Health Administrative Unit to function as Urban Primary Health Centre as well as engagement of human resources.

#### > Fund Flow:

- State Health & Family Welfare Samity release fund for 06 Municipal Corporations i.e. Asansol, Bidhannagar, Chandernagore, Durgapur, Howrah and Siliguri to SUDA. SUDA disburses fund to these MCs as per requirement.
- State Health & Family Welfare Samity release fund to Kolkata Municipal Corporation directly.
- State Health & Family Welfare Samity release fund to District Health & Family Welfare Samity for onward release to 82 Municipalities.

#### Programme Achievements under NUHM:

Establishment of Urban Primary Health Centre (U-PHC) – One Urban Primary Health Centre (U-PHC) is for 50,000-60,000 urban population. Under NUHM 459 U-PHCs have been sanctioned till date. Out of sanctioned no., 447 U-PHCs are already functional. Both preventive and curative services are being provided through these Urban Primary Health Centres (U-PHC).
