**Entomological Survey Report on Vector Borne Disease (Dengue) in the areas of Kamarhati Municipality**

**Place of Visit and Survey:** 14 and 13 no. Ward, Rail colony, A.C. Sarkar Road, B.B. Tala road and R.N. Thakur road of Kamarhati Municipality.

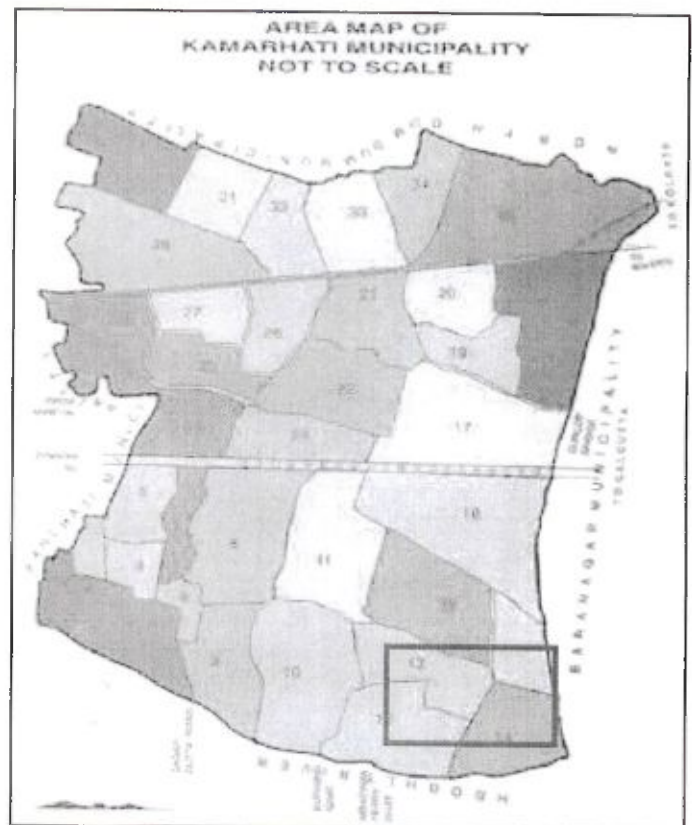

**Purpose of Visit:** Report of a few Dengue cases in ward no.14 and 13 (Rail colony, A.C. Sarkar road, B.B. Tala road and R.N. Thakur road) under Kamarhati Municipal area.

## Observations:

### Ward No.14 (Rail colony):

- Dakhineshwar Railway colony in ward no.14 was visited, which is a congested slum area with temporary establishments.
- Garbage consisting of bamboo, unmanaged tyres, tiles, plastic cups and earthen pots etc. was found in the space between the houses and in the drains running across the area which are the potential source of mosquito larval breeding.
- A blocked drain within the colony area was noticed which was overflowing at some places and full of garbage.
- The temporary establishments were unmanaged and use of water storage drums or plastic containers were noticed in some house, which were uncovered.
- A few wells were noticed in some houses, which were found to be covered with lids or mosquito nets and found to be satisfactory.
- The roof of a few temporary houses was with garbage such as unused utensils, bamboo, tyres, tiles, broken log etc., which may be a site for mosquito breeding.
- An unmanaged pond fully covered with water hyacinth, taro plants and other aquatic weeds was noticed beside the colony, where garbage dumping was noticed at the edges and may also be cause for vector breeding and transmission in the area.
- Temporary covering of blocked drain with bricks or tiles was observed in front of a few houses, which is probably not a solution to control the mosquito breeding.

### Ward No.13:

- Visited A.C. Sarkar Road, B.B. Tala Road and R.N. Thakur Road of ward no.14 to monitor VBD activities.
- One unmanaged land with a huge collection garbage was noticed behind Adyapith in the A.C. Sarkar bose road.
- Most of the drains in the area visited, were totally or partially blocked. However, desiltation was done in a few drains and garbage or silt was nnoticed at the side of the drains, which is to be removed immediately.
- Guppy fishes were noticed in a few drains. However, the chance of their survival is low if the drains is not cleaned as soon as possible.
- A few houses were visited to monitor the H-t-H and VCT activites and communication with the house members was done, which again showed the lack of proper VCT work in the locality. However, the H-t-H activity is satisfactory.
- A hydrogen peroxide manufacturibg factory was visited and no major larval sources were seen.
- House of Mrs. Sagata Banerjee(33/A B.B.Tala road) was visited, which was unmanaged and with unmanaged vegetation and collection of garbage at the backyward of the house.
- One unmanaged pond beside Indra Enclave (35/A B.B. Tala road) was observed which may be potential source of mosquito breeding and needs to be cleaned immediately before the arrival of breeding season of mosquito.
  - Drain infront of 10 Bachaspati para, house of Mr. Samir Mukherjee was blocked and desiltation required immediately to prevent further breeding of mosquito.
  - House of Mr. Subrata Chatterjee was visited where discussion with two dengue patients was undertaken and lack of VCT work mainly spraying was complained by th house owner.
  - An underconstruction site (48, R.N. Thakur road) was visited and numerous Aedes and Culex larvae were seen in the reservoir, which needs to be emptied or spraying with larvicidal is required.
  - The high drain infront of 49, R.N.Thakur road is totally blocked with a huge collection of garbage and cleaning is suggested.
  - Open manhole was noticed which may another reason for upsurge of dengue cases in this season.

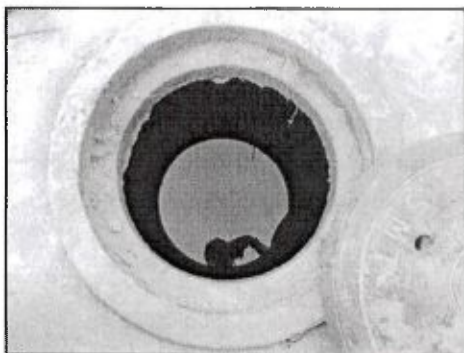


Fig.7. Open manhole in ward no.13

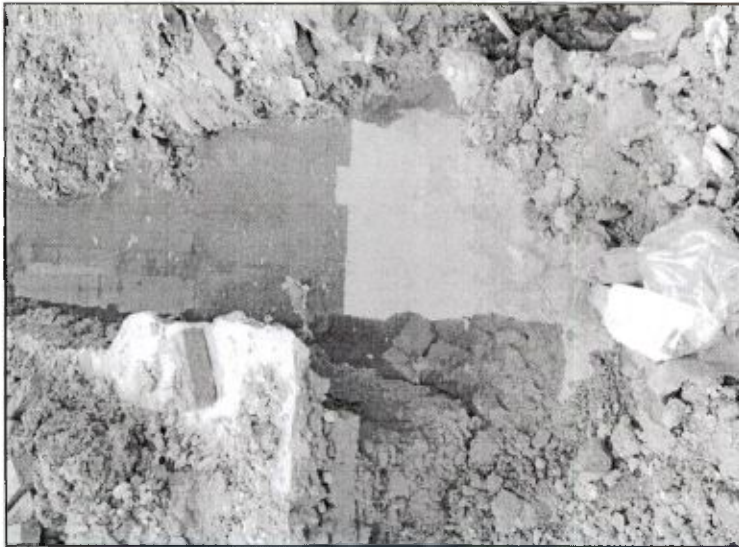




**Fig.8. Unmanaged pond beside Indra Enclave; Fig.9. Blocked drain in B.B.Tala road**

**Action taken:**

- Source reduction was done wherever noticed in the field to prevent further breeding.
- The manhole was advised to cover with a lid as soon as possible.
- De-silting of drains was advised to be done immediately and was informed to the H-t-H members as no VCT workers were present in the field.
- Cleaning of garbage in the unmanaged plots should be done immediately.
- Community awareness was generated in the houses visited and needs to be strengthened mainly in ward no.14 to prevent Dengue upsurge.
- VCT work needs improvement and lack of VCT work noticed at several places such as spraying or desilting of drains or garbage clearance.

**Conclusion:**

- The H-t-H team activity was upto the mark. However, the VCT work is lacking and needs to be strengthened.
- Community awareness by the Supervisors of H-t-H was satisfactory.
- The area needs to be monitored regularly to prevent further clustering of fever.

**Recommendations:**

- The unmanaged plots should be cleaned immediately (Action: S.I.).
- De-silting of blocked drains and cleaning of garbages in the vulnerable wards should be done in regular basis (Action: S.I. & Nodal Officer).
- A feedback report on action taken within 10 days is highly recommended.

**Sub : Observation of entomological surveillance at Telenipara**

Madam,

Number of Seropositive Dengue Cases have shown a declining trend all over the District except the Bhadreswar Municipality, to be more precise, at Telenipara area of the Municipality.

On 17-12-2019 Members of District Entomological Surveillance Team visited Ward No.13 and 14 of Bhadreswar Municipality.

The observation of the team indicate reasonably satisfactory quality of scavenging workers of the municipality at peridomestic areas including application of larvicide as per protocol, but the vector breeding within the household are alarming. The major areas of concern as identified during the visit of the team of Entomologists are as follows :

- 1) House visit by HtH team is very poor they are not at all visiting the households.
- 2) Household containers are not emptied and scrubbed at a weekly basis as proposed in the guideline.
- 3) The HtH team is not equipped with torch and ladle during house visit, thus the activity is ineffective.
- 4) Focal bleeding sites like well and blocked drain were identified which are devoid of larvivorous fish.

Under the given circumstances, keeping in consideration of the population density of the Wards of Telenipara, following recommendations are proposed.

- a) Intensive house to house activity involving HHW and volunteers.
- b) Simultaneous arrangement of destruction/sanitization of household containers.
- c) Intensive IEC towards awareness generation of the community.
- d) Attention of regular scavenging activities at the area should continue as usual.

The observation of Entomologists indicate active vector breeding even during 50<sup>th</sup> week of the year is a matter of serious concern. It is proposed to consider imposition of fine against defaulting HH as an exemplary step towards containment of VBD.


