Sub. : Selection formation & capacity building of Mahila Arogya Samiti (MAS) under NUHM.

Placed herewith communication bearing no. HFW/NUHM-697/2015/3484 dt. 16.11.2016 (at Flag - A) of the Commissioner, H & FW & Addl. Mission Director, NHM on the subject mentioned above.

In this context, this is to state that Mission Director NHM requested the concerned officials w.r.t. formation of MAS vide communication bearing no. H/NUHM-697/2015/2178 dt. 11.07.2016 (at Flag - B).

MAS, a women's group having 08 to 12 members is to be formed at slum level to cover 50 to 100 slum households. As per decision of the Competent Authority, MAS is to be formed out of existing Self Help Groups who are to be oriented to function as MAS.

For the purpose, Health & Family Welfare Department has proposed the following :

- ToT of the State Mission Managers under NULM on MAS training module at state level by Health & Family Welfare Department. The ToT will be held at SUDA.
- These State Mission Managers will train the Community Organisers (CO) at SUDA / Swasthya Bhawan under supervision of the State Project Management Unit, DHFW and SUDA jointly.
- These CO's will train the MAS groups of the ULBs with support of District Health & Family Welfare Department.
- Necessary expenditure in this regard will be borne by NHM, DHFW.

AMD, NHM has requested to suggest regarding feasibility of capacity building, group selection and monitoring of MAS by the State Mission Managers and Community Organisers of the ULB.

Examined the proposal of Health & Family Welfare Department.

Their proposal are as following :

- (1) SHGs who will be utilized as Mahila Arogya Samity (MAS) and who will be selected by ULBs need orientation.
- (2) State Mission Manager & Community Organiser working under NULM may be utilized for selection / formation and capacity building of MAS-SHGs.
- (3) 5 State Mission Managers will be oriented by Health & Family Welfare Department who in turn orient of Community Organiser regarding activities of MAS.
- (4) Finally Community Organisers will orient MAS at ULB level with the help of Health & Family Welfare Department representative of District level.
- (5) All necessary expenditure in this regard will be borne by Health & Family Welfare Department.

After examination & discussion with Project Officer, Health following proposals are given for consideration :

- (1) We may agree to the decision of MAS formation among existing SHGs and that will be selected by ULB itself, as per requirement of Health & Family Welfare Department.
- (2) Orientation of Community Organiser at State level may be arranged by SMMU, NULM. The representative of Health & Family Welfare Department may impart direct orientation to Community Organiser. No separate orientation of SMM will be required. However, they may take part during orientation.
- (3) District Health & Family Welfare Department will arrange orientation of MAS - SHG members at ULB level in consultation with the ULB where Community Organiser will act as resource person for imparting orientation.
- (4) Selection & Formation of MAS among existing SHGs will entirely be done by ULBs as per their decision.
- (5) Monitoring of MAS activities may be done by Health & Family Welfare Department however CO may be utilized for mobilizing & guiding MAS SHGs.

Sub. : Status on formation of Mahila Arogya Samiti (MAS) under NUHM.

A meeting was held with AMD, NHM, DHFW at Swasthya Bhavan on 01.06.2017 wherein Additional Director, SUDA and the Undersigned were present. A status on formation of MAS by 35 ULBs sent by NUHM is placed herewith at **Flag - C**. ULB wise status on formation of MAS is placed at **Flag - D**.

Summary on District wise status with regard to formation of MAS is detailed below :

It may be seen from the table above that (a) only 4 ULBs of East Medinipur have completed MAS formation, (b) ULBs of Bankura, Bardhaman, Dakhin Dinajpur, Darjeeling, Howrah, Kolkata, Malda, Purulia and Uttar Dinajpur not yet formed MAS, (c) ULBs of rest District have formed MAS partly.

SUDA is not given responsibility to facilitate MAS formation in Kolkata Municipal Corporation.

A convergence meeting was held at SUDA on 18th and 20th January, 2017 at SUDA Conference Hall with the Community Organizers of the respective ULBs and DMCHO, DPHNO, Accounts Manager of the District Health Office. The said meeting was facilitated by NUHM, DHFW. The Community Organizers were asked to form MAS in consultation with the Chairperson of the ULB concerned. After formation of MAS the ULB is to submit report as per prescribed proforma to the District in case of Municipalities and to SUDA in case of six Municipal Corporation.

Under the circumstances stated above, an action may be undertaken by mobilizing / involving Community Organizers of the respective ULBs facilitated by the experts under NULM so that the process of MAS formation could be completed by June, 2017.
