

Minutes of the Video-Conference held on 3.2.2017 between MoHFW, MoUD & HUPA for convergence with NUHM

A Joint video-conference Chaired by Addl. Mission Director (National Health Mission) with participation of Mission Directors of National Health Mission, Swacch Bharat Mission (SBM) and National Urban Livelihood Mission (NULM) was held on 3rd February, 2017 for convergence mechanism available in the ongoing programs of Ministry of Urban Development (MoUD), Housing and Urban Poverty Alleviation (HUPA) with the National Urban Health Mission (NUHM) of Ministry of Health & Family Welfare. Dr. K. Rajeswara Rao, JS (MoHFW-NUHM), Shri Praveen Prakash, JS (MoUD-SBM) and Shri Y.S. Awana, DS (DAY-NULM) participated in the Video-Conference. The Joint VC was also attended by officials from MoUD, HUPA, MoHFW, NHSRC, NIIFW, WHO & USAID. The List of Participants is at Annexure.

At the outset of the Video-conference, AS&MD (NHM) welcomed all the participants from the State Health Departments, Swacch Bharat Mission (SBM) and NUHM. Thereafter, the presentations were made by Dr. K. Rajeswara Rao, JS (MOHFW-NUHM), Shri Praveen Prakash, JS (MoUD-SBM) and Shri Y.S. Awana, DS (DAY-NULM) on NUHM, SBM & NULM respectively. The States/UTs welcomed the initiative of the Joint VC. The status of Odisha, West Bengal and Punjab informed that periodic reviews are held with Urban Local Bodies (ULBs). The States assured to utilise the platforms available under the three programs for convergence between NUHM, SBM & NULM.

The major points emerged from the Joint VC are as follows.

- In so far as possible the MOs, ANMs, ASHAs may be involved during the city triggering exercise initiated under SBM by the ULBs.
- All the ASHA/MAS are to be called as "Swacchagrahis" and may wear badges declaring them as "Swacchagrahis". The SBM will plan out incentives/remuneration which can be given for carrying out this initiative to ASHAs/MAS.
- The collaterals which are available with the State Mission Directors of SBM can be displayed at the PHC/CHC also.
- A micro-sanitation plan covering a radius of 500 meters -1 km around UPHCs/ UCHCs to be drawn up by ULBs. Correspondingly, the State Health Department to ensure adherence of quality guidelines in the earmarked PHCs/CHCs in the area of micro-sanitation plan.
- AS & MD (NHM) requested that MDs (NHM) of State/UTs, to share a roadmap with detailed plan of action and clear deliverables with the Ministry. The roadmap may be developed in consultation with officials of SBM & NULM.
- JS (UH) also stated that for success of all the 3 programmes there is need to institutionalize regular meetings with participations of all the 3 programme officials.

- JS (UH) stated that the next such Joint Video Conference would be held in the month of April, 2017 chaired by Secretary(H&FW), Secretary (MoUD) and Secretary(HUPA).
- The Mission Directors of all the States/UTs gave an update of the status of NUHM implementation in the States and assured that action on issues of convergence between the three Missions will be identified and carried out.
- All the three PPTs to be mailed to the participants of the Departments of Health, Urban Development and NULM at the State level.

The meeting ended with vote of thanks to the Chair and participants.

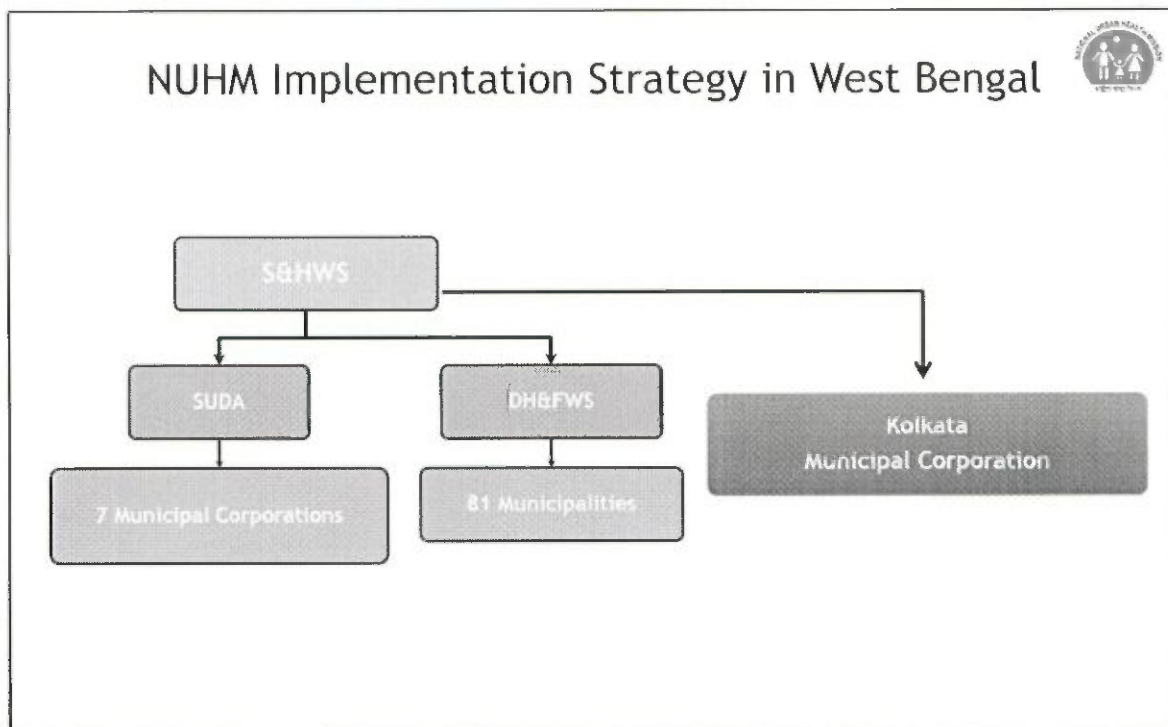

Fund flow mechanism and status of expenditure under NUHM	







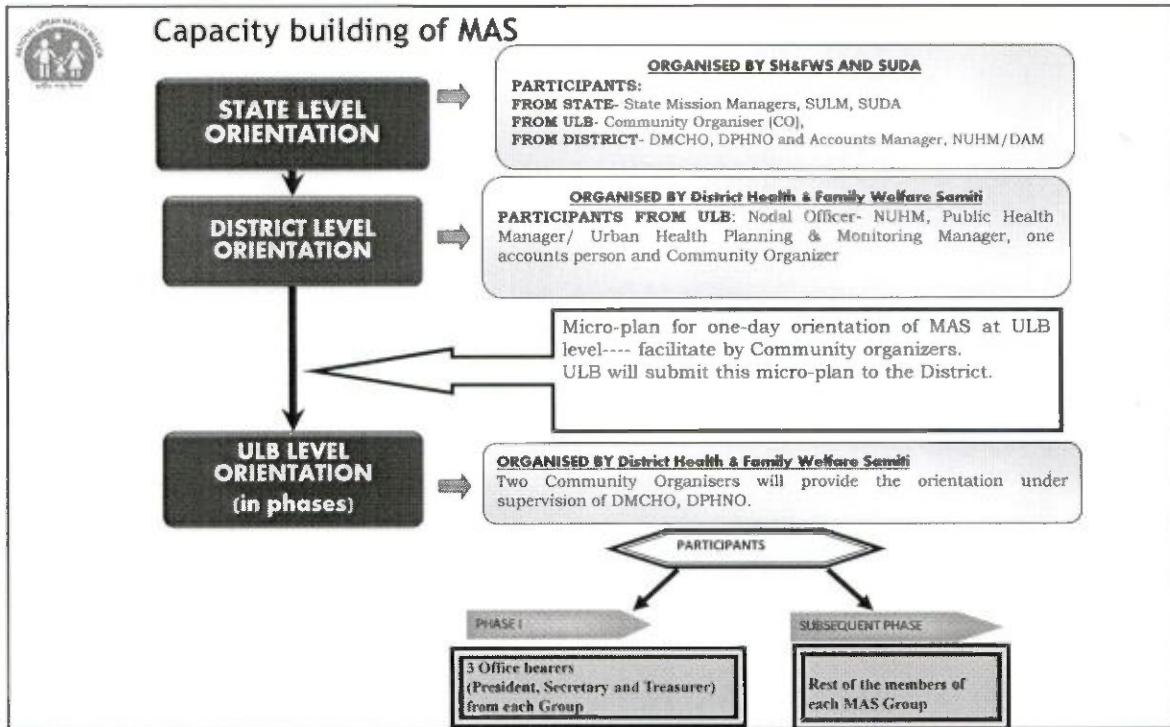
Community Process in West Bengal

**Proposed points for discussion in Joint Video-Conference of MOHFW,

1. Identifying & leveraging common platforms available for convergence activities under the following programmes :
 - NUHM
 - Swacch Bharat Mission (SBM)
 - NULM
2. Community level structures functioning under these programmes:
 - NUHM: ASHA / MAS
 - SULM: SHGs, Area Level Federation (ALF)
 - SBM: ODF Districts/Blocks in cities/towns more than 1 million population.
3. Sanitation/Health Workers under the **ULBs & ASHA** activities to be **undertaken jointly**.
4. One-time revolving fund of Rs 10,000 for 2 years provided to Self Help Groups. Revolving fund for SHGs/ALFs is provided for onward lending of its members and inculcating the habit of financial management in these institutions. Based on internal lending and the corpus generated by them, the SHGs are provided with bank loan for their livelihood and consumption needs. **The agenda of health can be included in regular meetings of SHG/ALF**. Also, **SHGs and ALF representatives may be trained on health issues**.
 - How can MAS & ALF work on common points.
5. A sub-committee of 10-12 representatives from existing ALFs can be identified as MAS where MAS does not exist. (Eg. Telangana State).
6. Other Common activities/ convergence areas between ALFs & MAS such as sharing of city maps for identifying slum/vulnerable population
7. Training and Infrastructure under these programme may be utilized.
8. UPHCs & UCHCs may also be involved in Kayakalp programme.

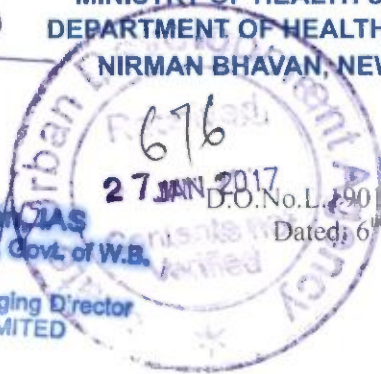

As you are aware, National Urban Health Mission (NUHM) was approved by the Union Cabinet on 1st May, 2013 as a sub-mission of National Health Mission (NHM) for providing equitable and quality primary health care services to the urban population, as poor people living in slums are deprived of essential primary health care services. They have to depend on the unorganized and at times unqualified, private providers for outpatient care leading to heavy out of pocket expenses.

2. Since the inception of the programme in 2013, an amount of Rs 5260.43 crores has been allocated under NUHM. An amount of Rs 2985.68 crores has been released to the States & UTs. The expenditure reported so far is only 45%. Moreover, Rs 375 crores for the FY (2016-17) had to be surrendered. In the current financial year, various activities for strengthening the programme implementation in States/UTs were undertaken such as regular video conferencing with all States/UTs for accelerating the pace of implementation of the programme by increasing the fund utilization, review meetings/workshops for Municipal Corporations, Involvement of Medical-Colleges in running UPHCs, Community Processes, Quality Assurance, Public Private Partnership etc.

3. I would like to draw your attention to the Joint letter from Secretary (Health & Family Welfare) and Secretary (Ministry of Urban Development) that was sent on 29th April, 2016 to the Chief Secretaries regarding accelerating the implementation of the programme in all the states/UTs. While some States have been able to work out effective implementation mechanism between Urban Local Bodies, Urban Departments and State Health Departments, there are states/UTs which are still experiencing limitations with regard to co-ordination, fund utilization and human resources. Major issues such as non-availability of land for health facilities (UPHC/UHC) construction, lack of linkages between Mahila Arogya Samitis under National Urban Health Mission and Self Help Groups under National Urban Livelihood Mission, lack of co-ordination and periodic meetings between Urban Local Bodies, Urban Development and State Health Departments, registration and transfer of funds under NUHM through PFMS, formation and registration of Rogi Kalyan Samitis etc have often been flagged.

4. I request you to kindly review the progress of NUHM in joint review meetings taken by the Principal Secretary/Secretary Health, Principal Secretary/Secretary Urban Development and Mission Director (NHM). The Municipal Commissioners and Officials designated for Urban Health may also be included in the review meetings. Similar periodic meetings need to be conducted at District Level also to sort out any coordination issues and accelerate the pace of programme implementation.

5. This being a high priority and relatively new programme, I also urge the States/UTs to accord top priority to NUHM implementation as its success would largely depend on your leadership and commitment. I would request you to kindly address the above issues. Kindly let us know if any further support is required from the Govt of India to ensure that NUHM is implemented expeditiously in your State/UT. As the PIP guidelines for FY 2017-18 have been issued, I request you to kindly make an effective and feasible SPIP so that the implementation of the programme will be visible towards achieving the desired health outcomes.

**Minutes of the Meeting held on 11.1.2017 between MoHFW and MoUD/HUPA
regarding convergence with NUHM**

A Joint meeting was held under the Chairmanship of JS (Urban Health) on 11.1.2017 to discuss the convergence mechanism between the ongoing program/schemes of Ministry of Urban Development (MoUD)/Housing and Urban Poverty Alleviation (HUPA) with the National Urban Health Mission (NUHM) of Ministry of Health & Family Welfare. Shri Praveen Prakash, JS (MoUD) and Shri Sanjay Kumar, JS (HUPA) along with other officials participated in the meeting. The List of Participants is at Annexure 1.

JS (UH) welcomed the participants and after introductions, initiated the discussion and requested JS (HUPA) to brief about the schemes of HUPA ministry where convergence can take place with MoHFW for NUHM program.

JS (HUPA) gave an overview of NULM program being implemented under HUPA. He informed that DeendayalAntyodayaYojana (DAY-NULM) organizes urban poor women in three tiered structure of Community Institutions viz. Self-Help Groups (SHGs), Area Level Federations (ALFs) and City Level Federations (CLFs). He mentioned that ALF provides handholding support to SHGs, facilitate SHG bank linkage, negotiate with higher level institutions for benefitting urban poor and facilitate member of SHGs in accessing benefits under various government programmes and schemes. He also informed that one time revolving fund of Rs. 10,000 for is provided to SHG for internal lending of its members. Registered ALF is provided with revolving fund of Rs. 50,000 per ALF for onward lending of its member SHGs.

It has been discussed that as the target population of both the programs viz NUHM and NULM is same in terms of community participation, it would be appropriate to develop linkages between MahilaArogyaSamities (MAS) under NUHM & Self -Help -Group/Area Level Federations under DAY-NULM. The convergence of ALF and MAS could be made in such a way that the Chairperson for both of the committees (MAS & ALFs) is common.

He suggested following 3 strategies which can be adopted for better linkages between MAS and ALF depending on the level of implementation in the States/Towns.

Option 1: Cities/States, where ALF exists but MAS is not formed

- A subcommittee of 10-12 representatives from existing ALFs can be identified as MAS.

Option 2: Cities/ States where both ALF and MAS exist

- MAS members can be included into SHGs and further be included in ALF.

Option 3: Cities/States where MAS is formed but ALF doesn't exist

- MAS members who are not part of SHGs will be encouraged to join existing SHGs and will further be represented in ALFs.

ALFs will support all community process activities under NUHM through MAS including preparation of plan as per the needs of urban poor and enable mobilization of community to benefit with health related schemes. ALFs can also facilitate identification of ASHA as per guidelines of MoHFW where it is not identified.

In addition to the above, States/UTs may develop their own mechanism of convergence between these committees based on local needs.

JS (UD) informed that a list of Nodal officers of 500 cities where Swachha Bharat Mission (SBM) is being implemented and list of 75 million plus cities has been maintained. List of these cities will be shared with MoHFW which could be utilized under NUHM program. He informed that Open Defecation Free (ODF) has been implemented in 70 blocks across the country. The Blocks found ODF is provided Rs. 10 lakhs for monitoring and surveillance. It was suggested that same may be replicated in urban areas also. ASHA and MAS could be involved under this initiative for generating awareness. It was suggested that Medical Officers of NUHM may also be involved in the existing platform of doctors/lawyers available under SBM for health education. The training is being imparted under NUHM for health functionaries which could also be imparted to the officials of NULM and SBM.

The action points suggested by JS (UH) are as follows:

- Joint letters from MoHFW, MoUD/HUPA to be sent to the Principal Secretaries/Mission Director of Health and Urban Development department of the States where MAS has been formed regarding establishing of the linkages between MAS and ALF. Where MAS does not exist, States/UTs may be informed about option 1 (which is already working in Telangana State), where subcommittee of 10-12 representatives from existing ALFs can be identified as MAS.
- It has been informed that a Joint Video Conference is being held on 3rd February by MoHFW and MoUD on NUHM implementation. It was advised that officials from HUPA may also participate in the VC wherein Principal Secretaries/Mission Directors of the States may also be invited.
- NUHM officials to be invited in the Video Conference/Meeting held by MoUD/HUPA pertaining to NUHM.

- A concept note to be prepared by DC (UH) regarding the convergence of schemes NULM, SBM and NUHM of the Ministries of Urban development, Urban Poverty Alleviation and Health.
- Convergence meeting to be carried out at regular intervals so that all schemes can be implemented with effective co-ordination.
