During visit to Dhuliyau Mpl., the undersigned met - CMOH, Muvshidabad and Dy. CMOH II.

Discussion held in respect of problem facing by Dhuliyau Mpl. in obtaining logistic support from District health office

In the said meeting, DPHN also joined, as desired by the CMOH. It was discussed that overall Routine Immunisation coverage by the ULBs are not at satisfactory level and there exist a communication gap between ULBs and District Health office. DPHN informed that out of 7 ULBs, FTSs (19 nos.) of 4 ULBs have already been trained by nursing training school for 25 days. After the training, the services of FTSs are not being utilised adequately.

The undersigned presented the CMOH to convene a meeting wherein all the ULBs and concerned health officers of DPHN will remain present.

The said meeting is scheduled on 05.01.2010 - the letter is enclosed.

No. of participants will be 96. As it is part of strengthening RD, expenditure for conduct of meeting @ Rs.35/- (Rupees thirty five) only; thus total expenditure of Rs.3360/- (Rupees three thousand three hundred sixty) only may be borne out of KUSP fund. Berhampur Mpl. may be entrusted with the responsibility. Submitted for kind approval.




