

Sub.: Provision of Computer with accessories to the Health Programme Unit of 40 KMA ULBs under Health component of KUSP.

So far the Health sector of the ULBs do not have access to the e-communication. During different discussion sessions / meetings with the HOs & AHOs, it has been learnt that at least one computer along with accessories is urgently required by the Health section of the ULBs to computerize health data received from the grass root level functionaries, compilation & preparation of monthly reports, facilitating regular communication for speeding up of activities, work on re-training and the like.

Furthermore, there is a wide communication gap between the general section of the office and the Health section causing delay in each stage. In this context it is to state that not only the provision of computer but also internet connection will help in speedy communication.

Under the circumstances stated above one computer with necessary accessories may be provided for the present to the 40 KMA ULBs specifically for their Health section.

Already Pujali Municipality has prayed for sanction of computer under reference no. 1213(4)/P.M./Engg-32(Computer)/05 dt. 14.11.2005 for their Health Wing (Copy enclosed). The Chairman, Pujali Municipality may be requested to furnish the status on Basic Computer Training undergone by the Health Personnel and forward the Undertaking as per proforma.

This is to mention that personnel from Health sector of the ULBs were trained in Basic Computer through the recent training programme organized by KUSP (copy of the list enclosed). Out of 40 ULBs, 21 ULBs completed training in Computer. However, we may issue a letter to the Mayor / Chairperson of the ULBs regarding (a) the status on Basic Computer Training undergone by HO, AHO, UHIO, STS and other health personnel, (b) requirement of Computer with accessories for computerization of health related data and preparation of Report. On receipt of the required information from the ULBs further necessary action be taken by this end.

Draft letter for Pujali and other 39 ULBs are enclosed which may be issued, if approved.

It has come to our notice that in some ULBs Gr. A-C employees belonging to the Health Department have not been included in the list of employees undergoing Basic Computer Training through KUSP programme probably due to oversight. I therefore request you to include the relevant employees of your Health Department in the Computer Training Programme, if they were previously not included.

Keeping in mind, the various stages of implementation of the Computer Training Programme at different ULBs, the following is proposed from this end:

Or, b) Candidates to go to nearest ULB undergoing training.	KUSP support in terms of fees for training should remain unchanged as intimated in our earlied letters.	
2.	Training completed for employees but for CIC to start.	Take training along with the CIC members.		
3.	Training yet to start/just started (say 1 st month in progress).	Include the names in the list with necessary amendment as and where required in the Contract.
