



I would like to inform on the above noted subject that personnel engaged to this office under Community Based Primary Health Care Services are receiving remuneration so meagre that is not affordable to maintain minimum needs in the context of current market situation. Those staffs started their engagement vide order no.-111-MA/c-10/3S-55/2005, dated-02/02/2007 through the order of Jt. Secretary, MA Dept., Govt. of West Bengal. with an initial remuneration Rs.5000/- (Five thousand per month). Those staffs were also being benefited an yearly fixed increment through your kind office in three phases following G.O. dated 24th December, 2008, 26th February, 2009 & lastly 644/MA/C-10/3S-6/2010 dtd.6th Aug.,2010 of an amount Rs.500/-, Rs.250/- and Rs.500/- respectively. Now they are receiving remuneration likewise:-

Sub: Parity in monthly Consolidated Remunerations in respect of Health Functionaries on contract under Community Based Primary Health Care Services Programme (CBPHCS)

Sir,

Hope you are aware of Community Based Primary Health Care Services Programme (CBPHCS) introduced in our municipality since in the year 2006 which is funded by Health & Family Welfare Deptt. Govt. of West Bengal and SUDA is the implementing agency. Health care functionaries at grass root level rendering their tireless yeomen services through door to door health visit, health sub-centres attended by Medical Officers and monitored by staffs of the Monitoring & Supervision Cell. In our municipality there are 40 no. of regular HHWs, 8 no. of FTS, 5 no. of staffs of M&S Cell and 2 no. of Medical Officers under guidance and control of Health Officer. The significant improvement is reflected from the health indices like Infant mortality rate, maternal mortality rate, crude birth rate, crude death rate and other health programmes.

Inspite of all these services and success there are disparities and anomalies in the consolidated remuneration to the contractual employees under CBPHCS with other employees of various health sector under West Bengal state Health & family welfare Samiti. Based on the recommendation of the committee, constituted to remove such disparity may I suggest to review the group and pay of consolidated remuneration allowed to our contractual employees as detailed below —

Sir, Disparities and anomalies in the consolidated remuneration allowed to contractual employees engaged in various health sector programmes under the WBSH&FWS have long

been a matter of concern. Therefore, a committee had been constituted to remove such disparities and anomalies and bring about parity in the pattern of remuneration.

Based on the recommendations of the committee, the WBSH&FWS has decided to revisit the pattern of consolidated remuneration allowed to contractual employees engaged in different health sector programmes under the WBSH&FWS as set out in Annexure II to this order.

Annexure II will become effective only after the submission of the relevant information in the prescribed format in Annexure-I by the State Programme Officers to the WBSH&FWS, followed by specific sanctions based on such information by the Executive Director of the Samiti.

Under no circumstances should the Programme Officers grant revised remuneration as set out in Annexure II, without such specific approval.

- The system of allowing annual increment shall be with held for all such employees who have not rendered service continuously more than 10 years and not satisfied all the conditions referred in Finance Department Memo No. 9008-F(P) Dated 16.09.11.
- Renewal of engagement of all such contractual employees, which in every case shall be reckoned as a fresh contract, will henceforth be effected from 1st April of each year and may invariably end on 31st march of the following year on the basis of specific appraisal in prescribed format and in consultation with Human Resource Cell of the WBSH&FWS. The contract will end automatically on 31st March of the following year, unless renewed in the above manner
- 5 At the time of renewal i.e., on 1st April of the year, monthly contractual remuneration of the contractual employee concerned shall be revised as per recommendation of the Human Resource Cell under WBSHFWS.
- If any fresh employee is recruited at any point of time after 1st April and prior to 31st March, his/her first contractual tenure shall strictly be upto subsequent 31st March and that monthly remuneration shall be fixed by keeping parity of minimum remuneration of contractual employees of same group at that point of time and invariably in consultation with the HR Cell. First re-fixation of remuneration of such fresh recruited employee will be due on 1st April immediately after his/her completion of 12 months service.
- If for the interest of any programme, a fresh contractual employee is recruited whose designation has not been included or covered in any of the group given in Para 1 above then before recruitment that designation either be included in any of the existing group or in a new group in consultation with the HR Cell.
- 8 The monthly contractual remuneration of all Groups as prescribed in Para 1 above, has been fixed for bringing parity amongst the employees of same Group. But if for this revision, existing remuneration of any contractual employee is reduced then the matter may immediately be brought to the notice of Executive Director, WBSHFWS
- 9 Job Chart for all categories of contractual employees will be introduced or modified by the HR Cell in due course.
- Renewal of contract of any contractual employee will not be allowed if the employee fails to attend his/her duties in 240 days in a year of tenure or 20 days average per month if the period of tenure is less than one year. In this respect sanctioned period on leave with pay shall be counted towards determination of the Number of days worked.
- There are some retired employees engaged on contract in different programmes. Remunerations of such contractual employees will be as per extant government orders in force.

Clarification regarding revision of consolidated remuneration, if required, may be sought from the WBSH&FWS.

Health care functionaries at grass root level rendering their tireless yeomen services through door to door health visit, health sub-centres attended by Health Officer and monitored by staffs of the Monitoring & Supervision Cell. In our municipality there are 34 no. of regular HHWs, 07 no. of FTSs, 05 no. of staffs of M&S Cell and 01 no. of Medical Officers under guidance and control of Health Officer. The significant improvement is reflected from the health indices like Infant mortality rate, maternal mortality rate, crude birth rate, crude death rate and other health programmes.

Inspite of all these services and success there are disparities and anomalies in the consolidated remuneration to the contractual employees under CBPHCS with other employees of various health sector under West Bengal state Health & family welfare Samiti. In enclosing herewith the prayer in original of Honorary Health Workers (H.H.W) and First Tier Supervisors (F.T.S) of Kaliyaganj Municipality for enhancement of their honoraria, I would like to draw your kind attention to the fact that the 17 Nos. of H.H.Ws and 4 Nos. of F.T.Ss have been engaged and continuing to render their respective services in different wards under Kaliyaganj Municipality since April 2007 with the meagre honorarium of Rs. 1000.00 and Rs. 1170.00 only per month respectively. But due to abrupt hike of market price day after day the Govt. has been considering the economic situation of the illpaid H.H.Ws and F.T.Ss and enhanced their honoraria from Rs. 1000.00 to Rs.2500.00 and Rs. 1170.00 to Rs. 2670.00 only per month respectively from time to time to allow them lump sum support in their daily life and as such last enhancement was made w.e.f 01.04.2010 Vide Govt. Notification No- 644/MA/C-10/3S-6/2010 Dt-06/08/2010.

Unfortunately since Two years, thereafter no any financial benefit nor any enhancement of their honoraria has yet been considered for payment to the H.H.Ws and F.T.Ss for which they are actually deprived and disheartened in performance of their time bound and routine bound duties which may kindly be looked into sympathetically.

Considering the above uttered financial condition of the H.H.Ws and F.T.Ss, I would like to strongly recommend their prayer for enhancement of honoraria with immediate effect for a reasonable amount of honorarium for their livelihood.

An early action in this regard is urgently solicited.
