Sir,

I like to inform you that this Municipality has no Trained Nurse/FTS (First Tier Supervisor) for periodical ANC checking for the poor pregnant women who are residing within the Municipal area. As such this Municipality is not in a position to provide at least 4 times Medical check-up (which are essential) services for the pregnant women. Due to deficiency of this infrastructure, this Municipality advises those pregnant women to attend the BPHC for their complete check-up. But it is very often noticed that such pregnant women (holding APL cards) disagreed to attend the BPHC for their necessary time to time checking before delivery, considering for expending additional amount for three wheeler bicycles/Autos etc. As a result, the reasonable Medical course before delivery does not complete and such women may face life risk at any time before/after their delivery. But on the other hand some pregnant women (belongs to BPL category) attend this CBPHC of Jhalda Municipality for their routine check-up but unfortunately we can not provide the required Medical Services timely in absence of any Trained Nurse/FTS (First Tier Supervisor) and also they express their inability to attend the BPHC in order to avoid conveyance cost. Naturally in these cases they may face life risks.

Considering the aforesaid position you are therefore requested kindly to open a permanent Health Camp with experience Trained Nurse(s) within the premises of this Municipality if possible, otherwise kindly to arrange alternatively for necessary Training of our untrained FTS (First Tier Supervisor), so that necessary Medical Services may be provided to the pregnant women residing under this Municipality.

NOTIFICATION

A project for taking up Community Based Primary Health Care Services (CBPHC) in 63 Non-KMA Urban Local Bodies (ULBs) has been taken up with the budgetary support of Health & Family Welfare Department in line with the Community Based Health Care Programmes implemented in the remaining Urban Local Bodies earlier under various other Health Projects. For successful and smooth implementation of the Scheme, one Health Officer is required to be engaged in each ULB on contract basis with contractual remuneration. The matter was under active consideration of the Government for sometime past.

2. After careful consideration of all aspects, the Governor has been pleased to accord sanction to the creation of 63 posts of Health Officer, for the 63 ULBs, for covering Community Based Primary Health Care Services (CBPHC). The Health Officer shall be engaged by the concerned Urban Local Body on contractual basis.

3. The contractual remuneration of the Health Officers will be fixed taking into account the initial basic pay in the Scale of Rs.8000-13500/- plus Dearness pay as well as Dearness Allowance as is admissible on the date of contractual appointment.

4. The Selection of the Health Officer will be made through a selection process by the respective Urban Local Bodies in the manner stated below:-

- a) Names of Candidates be invited through Notification at least in two daily newspapers (1 Bengali, 1 English).
- b) Candidates must have minimum qualification of MBBS from any recognized University with desirable qualification of 2 years' practicing experience.
- c) Conditions regarding minimum and maximum age and other criteria on nationality & caste shall be governed by the existing orders of the Government for recruitment of Medical Officers.
- d) A Committee comprising Chairperson of the respective ULB as the Chairman, representative of the District Magistrate, representative of the Chief Medical Officer of Health of the district, an officer nominated by the Director of Local Bodies or the other members shall conduct the selection process.

5. This order entails discontinuation of the same time of Medical Officer who are now continuing in the Urban Local Bodies on contractual pay of Rs.300/- per day subject to a maximum of Rs.6000/- p.m.

6. This order issues with the approval of the Cabinet and concurrence of Finance Department vide U.O.No 625 Cr.P(Service) dated 21.2.2008.

- The names of regular candidates (Twelve nos.) only is to be listed and put up in the notice board of ULB, asking them to function as HHW with effect from 9th August, 2007 and inform Director, SUDA accordingly with regard to date of joining of HHWs.
- The Chairman of the ULB is to allocate the area of operation for each HHW.
- One HHW will cover a population not exceeding 1,000 BPL contained in a single ward. A ward having less than 1,000 BPL population will have one HHW.
- The HHW shall be responsible for Primary Health Care of BPL families under her jurisdiction and be responsible for both public health and health statistical data collection for the entire population within the ward.
- The ward Councillor will monitor and supervise the activity at ward level.
- HHW Kit bag along with contents provided by SUDA is to be given to all the regular HHWs only.
- To start with, HHW will conduct baseline survey of the allotted BPL families as per the proforma already provided by SUDA, to be checked and scrutinized by HO / MO / SI, who will compile the data ward-wise and ULB-wise.
- Job responsibility of the HHW (working hours 12-00 Noon to 4-00 P.M. of each working day) is :
 - fortnightly home visit to each BPL families,

I would like to state that Jhalda Municipality is one of the oldest municipalities in West Bengal, an urban population of 20,000 approx. measuring an area of 8.65 sq. K.M. The Municipality was established in 1st July 1988, when this area was within the state of Bihar. Although Jhalda was declared as urban area but actually it is rural in nature having a limited financial resource. To serve the urban people of this area with medical aid, the then Manbhum District Board used to run a hospital for which municipality had to part with their own land for construction of Hospital Building.

After the merger of this area with West Bengal, in terms of the policy of the Govt. of West Bengal, the Management and Control of the said hospital including with its assets and liabilities were taken over by the Govt. of west Bengal and thus this hospital was converted to Sub-Health Centre and run upto 1971.

There after for obvious reason; the Sub Health Centre (Hospital) was shifted to a rural area depriving the Urban people so long the benefit enjoyed by them getting free medical care and free medical aid from the said Sub Health Centre (Hospital). The urban people and the municipal authority jointly raised protest against this transfer as no alternative arrangement was made by the govt. to extend the medical aid to the urban people, but to no effect.

Thus since 1971, this urban area is left without any Govt. hospital and thereby the urban people have been deprived of any medical help what so ever, for an in action of the then authorities and the weaker section of this locality are the worst victims to get any medical help free of cost for want of any medical centre either run by the Govt. or by the authority. I am constrained to say that this is the municipality where there is no existence of any Hospital or Medical Centre within this area to extend medical help to the urban people. I am thankful to the authority of Zilla Parishad for their compassionate view to the long standing demand of the people of this urban area for immediate establishment of a Hospital cum Maternity ward at Jhalda.
