During the tenure of his service as Medical Officer here, he remained frequently absented from his routine duties in the sub centre where he aught to attend but attended other sub centre. Later the matter of such irregularities was made regular.

Subsequently he informed that due to his illness he was compelled to remain absent which then seemed to be deliberately absence on his part and he was asked to join. Having such notice he furnished supporting evidence of his ailment. In this phase of time there was no Board of Councillors and due to prevailing irregularities owing to absence of the Medical Officer his remuneration was paid but at delay.

It made him furious and as such he tried to haras the then municipal authority by sending letters of allegation to different corners about fake latches as if done by the municipal officials. Subsequently the matter was taken up by the newly elected Board of Councillors. The Chairman examined the matter thoroughly and after patient hearing to the Medical Officer personally on call, discussed with him on the points of his grievance and made him understand the genuineness of his claim and of the indisciplinary acts he done on the other hand. The Medical Officer after having been convinced of his misdeeds begged apology in writing. The municipal authority for the sake of smooth running of the RCH programme for which a Medical Officer is necessary and in consideration to have medical facility to administer for the benefit of the poor people of this municipality agreed to retain the medical officer to continue. Accordingly, the Chairman, after regularizing the leave allowed Dr. Sailendra Kumar Chowdhury to work as Medical Officer. Since then Dr Chowdhury is performing the duties of Medical Officer. The leave which appeared to be sanctionable there after regularized and other irregularities those are pardonable were made good on the face of apology in writing. (Copy enclosed)

By this time due to pancity of fund the said Medical Officer under Urban RCH could not be paid his salary. As a result, the salary of medical officer stands due for 8 months from April'2015 up till date.

Medical Officer, Dr. Sailendra Kumar Chowdhury has been working regularly under the Urban RCH in this Sainthia Municipality during this period in question. And as such you are requested kindly to release fund towards his salary of Medical Officer for the months of April'2015 onwards.

All of the above workers are CONTRACTUAL STAFFS. They are entitled to leave for only 42 days in one year. Period of maternity leave is not clear for CONTRACTUAL workers. There is no provision for Earned Leave as no service book is there in case of contractual workers. In our 4 health Sub centers distributed in 4 different locations within the jurisdiction areas of the municipal administration, more than 1,000 patients and maternity cases with newborn children are regularly served by the Medical Dept per month with the allotted health workers engaged in confined subcenters. Usually 3 to 4 health workers are allotted to each sub center to assist the Medical officer. One of them with higher scale is the Superviser. Superviser, by orders of SUDA, Govt of WB, is responsible to maintain all important records and registers on daily and monthly basis to be produced to the Medical officer who checks the documents every month in the first week. Subsequently, after checking, the documents are finally placed to the Chairman by the Medical officer as his duty.

Now, with absenting workers on the rise in health section, it has become virtually almost impossible for the medical team to serve as a coherent unit for the last six months. It is obscure why the workers are absenting themselves from working place for such long periods without knowledge of the Medical officer but receiving their salaries regularly through computerized banking system.

Urgent steps may kindly be taken to help smooth running of services by

1. Replacement of defaulting staffs.

2. Without pay implemented for workers crossing permissible limit of leave previlages.

All of the above workers are CONTRACTUAL STAFFS. They are entitled to leave for only 42 days in one year. Period of maternity leave is not clear for CONTRACTUAL workers. There is no provision for Earned Leave as no service book is there in case of contractual workers. In our 4 health Sub centers distributed in 4 different locations within the jurisdiction areas of the municipal administration, more than 1,000 patients and maternity cases with newborn children are regularly served by the Medical Dept per month with the allotted health workers engaged in confined subcenters. Usually 3 to 4 health workers are allotted to each sub center to assist the Medical officer. One of them with higher scale is the Superviser. Superviser, by orders of SUDA, Govt of WB, is responsible to maintain all important records and registers on daily and monthly basis to be produced to the Medical officer who checks the documents every month in the first week. Subsequently, after checking, the documents are finally placed to the Chairman by the Medical officer as his duty.

Now, with absenting workers on the rise in health section, it has become virtually almost impossible for the medical team to serve as a coherent unit for the last six months. It is obscure why the workers are absenting themselves from working place for such long periods without knowledge of the Medical officer but receiving their salaries regularly through computerized banking system.

Urgent steps may kindly be taken to help smooth running of services by

1. Replacement of defaulting staffs.

2. Without pay implemented for workers crossing permissible limit of leave previlages.

Rinki Mahanta, Health Assistant under CBPHCS Programme of this Sainthia Municipality working on contractual basis, has submitted leave application w.e.f. 16.04.2014 to 28.08.2014 total 135 days as maternity leave supported by medical certificate and placed it to this municipal authority. But there is a confusion as to whether the leave should be granted "with pay" or "without pay".

In this context memo no. SUDA-63ULB/33/08/325(63) dated 08.12.2008 may kindly referred to where Model Leave Rules of Municipal Employees (Rule 24) is to be followed.

In the memo no. 392/MA/C-10/3S-28/2007 dated 08.04.2008 of the Municipal Affairs Department the entitlement of Maternity Leave applicable to such contractual employees under HHw Scheme is admitted to be applicable in cases of employees engaged under CBPHCS Programme with pay up to 135 days.

Accordingly it appears that the present employee proceeding on maternity leave may be granted with pay for the period of leave.

However, the leave application of contractual employee Smt. Rinki Mahanta, Health Assistant under CBPHCS Programme along with medical certificate may kindly be perused and a valued opinion may be passed as to whether Sm. 


