Placed herewith communication of the Chairman, Barrackpore Municipality vide no. CMBM/Health/HO/2012/SUDA/021 dt.21.04.2012 forwarding list of Furniture & Equipments along with existing & required items & nos. for ESOPD and MH.

The compiled data regarding existing & required item of Furniture & Equipment for ESOPD and MH along with cost involvement, as submitted by the ULB, have been prepared and placed. The total cost involvement is Rs.1,18,66,000/- (Rupees One Crore eighteen lakh sixty six thousand) only.

The Chairman in his communication stated that existing 30 bedded maternity Home would be converted to a Modern Multi-disciplined Hospital of more than 80 Beds and the present ESOPD to a Multi Speciality Clinic with Modern Diagnostic Facilities.

Rationale for some of the Furniture i.e. Steel Almirah-30 nos., Refrigerator - 12 nos., visitors Chair- 300nos, & equipments i.e. Doppler Machine- 3 nos., Centralised Oxygen supply system and the like could not be assessed. Further communication to the Chairman for sending clarification in this regard may increase aspiration level.
