

#### Demography

- Garulia is having a population of 85106 (as per census 2011)
  - 1. Location & General description of the Municipal office

Garulia Municipality is bounded on south by North Barrackpore, on west and North by Hooghly River, by Bhatpara Municipality and Barrackpore Kalyani express Way in the east. The Municipality of Garulia is 25 Kms away from Kolkata proper. Garulia is situated on the eastern bank of Hooghly River. Nearest Railway stations are Shyamnagar and Ichhapur. The municipality comprises of unplanned growth of households and divided into 20 wards.

Name of the project proposal: "Establishment of Maternity Home at ESOPD Building of Garulia Municipality".

Objective of the project: To deliver better health care facilities to the poor women.

**Executive summary:** A maternity home for the birth of babies is a necessity in the municipal area. Assisting mothers in achieving safe and healthy births in an integrated primary maternity unit is the ultimate aim. ULB has to be specializing in ensuring safe and sustainable maternity service for poor women.

Rationale: The Garulia Municipality comprises of 20 wards which is having 87 slums(notified). The economic conditions of people living in slum areas is bad. There is no Hospital in the Garulia Municipal area and there are only three small Private Nursing Homes which provides facilities against

payment. In case of emergency or in the last stage of labour the expectant mothers has to be admitted to North Barrackpore Municipality Matrisadan which is 4 kilometers from Garulia or else to Bhatpara State General Hospital which is 5 kilometers from Garulia. Suitable place & cost factors involved in staying outside before delivery is also not up to their reach because of their poor economic status. The people living here used to go to private nursing homes or else they have to travel hospitals which are far away from the place.

Present situation analysis: At present Garulia municipality residents including slum dwellers depend on E.S.O.P. D. or health centers under IPP VIII or CUDP III. There are only two nursing homes rendering services to that part of population who can afford the cost. Problems of economically depressed community are not fully addressed though govt. schemes which are in operation namely (IPP-VIII) and CUDP III.

100% pregnant women are not covered under institutional delivery due to lack of awareness. Further awareness building is needed to bring all women under immunization programme to pre and post natal care. Problem of anemia and nutrition problem is predominant among children in the marginalized children.

Justification / need of the proposed project: Since there is no specialty Hospital having Maternity Home or Government Hospital in the ULB area, utmost care should be given in the Health sector, so that the common or poor people can get the services in time.

Main perspective toward setting a maternity ward is to avoid home delivery, premature delivery and also to avoid foetal death. For better follow-up of the pregnant mother is utmost required in Garulia Municipality at ESOPD building.
