This is to bring your kind notice to the fact that Gayeshpur Matrisadan was established on 1st September, 2001 under IPP-VIII Health Project financially assisted by the their UHIP, KMDA & presently SUDA w.e.f. 1st April, 2008. The matrisadan having 20 beds started keeping view of the local B.P.L. pregnant mother's treatment at low cost with well equipped 0.T phototherapy unit and incubator etc.

On & from 3rd August, 2004, the unit is not running smoothly due to post operative casualty for inadequate posting of R.M.O. After that incident, several efforts have been taken by the Municipal Authority but all efforts are in vain due to non-cooperation of specialist doctors, R.M.O. at their unrevised nominal consolidated pay under the project & as suck all efforts are in vain

At present, Municipal Authority is willing to run the maternity home along with General Hospitals for the benefit of the local inhabitants but municipality is not in such financial position to run the unit from its own.

The information regarding maternity is given below for your ready reference:-

- Present cost of 3 storied 1675.86 Sq.mt. building with ramped 148.72 Sq.mt. is more than Rs.2 crores.

If the maternity home with general hospital will run smoothly then the burden of Jawaharlal Neheru Hospital, Kalyani may be reduced.

The main problem of this unit is inadequate Specialist Doctors & Residential Medical Officers due to their low remuneration.

To consider the gravity of that situation you are requested to take necessary steps by taking the maternity home including general hospital with existing staffs & facilities o special attention by sending specialist doctors & R.M.Os to maternity home at the earliest.

The World Bank in their Aide-Memoire dt. 29.12.99 against component one of the Benchmark advised appointment of at least one Staff Nurse and one Medical Officer (preferably Lady Doctor) per municipality to provide quality outreach services and supportive supervision including on the job training for the Honorary Health Workers. The target date for finalisation of the issue was fixed on 31st March, 2000.

In consideration of the fact that 23 posts of Assistant Health Officer for manning one each of equal number of local bodies were already created by the State Municipal Affairs Deptt. to look after the works of IPP-VIII, a proposal for creation of the remaining 17 posts of Assistant Health Officer/Medical Officer (preferably Lady Doctor) and 40 posts of Staff Nurse was sent to the aforementioned Deptt. for doing the needful. The proposal was placed before the Apex Committee of Family Welfare (Urban Slums) Project – IPP-VIII in its 7th meeting held on 16.2.2000. The Committee directed the Municipal Affairs Deptt. to act upon the proposal so as to enable the State Govt. to take a decision in this regard. Thereafter the decision would be forwarded to the Ministry of Health & Family Welfare, Govt. of India, for their consideration. No decision has, however, been communicated by the State Govt. as yet.

In the meantime, during the further Review Mission of Family Welfare (US) Project and a corresponding Aide-Memoire dated 22.5.2000 the World Bank has again advised to complete appointment of at least one Staff Nurse and one Full-time Medical Officer per municipality on contract basis (including daily wage) to ensure quality care by the target date of June 30, 2000.

Since no decision has yet been communicated by the State Government, it is imperative to act upon the recommendation of the World Bank in the interest of the Project. In this view of the matter the project has decided to the engagement of 17 Asst. Health Officer/Medical Officer and \$9 Staff Nurses on contract basis on daily wages in the local bodies indicated against each — in Annexure—I and Annexure—II respectively.

The Chairpersons of the local bodies mentioned in Annexure- I & II shall engage the personnel on daily wage basis in terms of this order. The engagement of the doctors (preferably Lady doctors) and the nurses should be made as per guideline enclosed.

The expenditure on this account will be borne by the IPP-VIII during the project period from the head of account "Operation & Maintenance" in the Budget of IPP-VIII, Calcutta.

The concerned Chairperson of the local bodies are being informed.




