

Placed herewith communication of the Ld. Advocate Smt. Animita Bhattacharya dt. 18.01.2016 w.r.t. W.P. No. 27532 (W) of 2015, Sima Chakraborty & Ors Versus the State of West Bengal & Ors.

The undersigned while going through the matter, the following observations have been made :

Page No. 10, serial no. - 4 It is written as "Scheme of the Department of Health & Family Welfare"	UPHCS (erstwhile CUDP III & IPP-VIII) are funded by Dept. of Municipal Affairs and fund routed through SUDA.
Page No. 13, serial no. - 7 The petitioner cited Govt. order bearing no. 9008-F(P) dt. 16.09.2011	In the said order it may be seen at serial no. - xiv that the final approval will be given by the ACS / Principal Secretary / Secretary as the case may be of the concerned Department, after exercising necessary checks & balances and ensuring that any in eligible person does not get the benefits of the order. It is not known whether the final approval had been issued by the Department. It is also not known as to whether Uttarpara Kotrung Municipality submitted employee-wise information as per prescribed annexure of Finance Department to the Department.
Page No. 18, serial no. - 12	Project Officer (Health), SUDA as marked as respondent 05, is the employee of SUDA. Particulars / documents / information lying with CMDA is not available at SUDA. It may be mentioned here that both CUDP III & IPP-VIII were implemented by CMDA. In the year 2008, both the Programmes were put under one umbrella of SUDA, though related file etc. were not available with SUDA. Furthermore, implementation of Govt. order bearing no. 9008-F(P) dt. 16.09.2011 needs final approval from the respective Department.

As such respondent 04 (Director, SUDA) and respondent 05 (Project Officer, Health, SUDA) are not directly related with the matter.

The petitioner prayed for implementation of Govt. order bearing no. 9008-F(P) dt. 16.09.2011 w.r.t salary & retirement benefit by the ULBs.
