Placed herewith communication of the Chairman, Dhupguri Municipality bearing no. 214/DPGM/2010 dt. 13.05.2010 regarding engagement of Health Officer under CBPHCS in Dhupguri Municipality.

The Chairman has expressed a great difficulty towards implementing CBPHCS scheme without having HO in position as the Health programme is technical one. For the purpose, the Chairman has suggested some remedial measures to overcome the present difficulty.

Suggestion of the Chairman in the instant letter vis-à-vis our views are tabulated below :

Suggestion of the Chairman	Our views
1) To make necessary arrangement by SUDA for further advertisement for the post of HO.	In spite of floating advertisement inviting applications for the post of HO centrally by SUDA twice, Dhupguri Municipality could not engage HO. Out of 63 ULBs, implementing CBPHCs it is not only Dhupguri Municipality but also 22 more ULBs under CBPHCS are not having HO in position. Moreover, the ULBs who are having HO in position are also experiencing problems due to frequent change of HO. In this context, it is felt that if the HOs under CBPHS be engaged on permanent post and at par with present remuneration admissible in terms of ROPA, 2009, the crisis due to vacancy for the post of HO may be solved. However, if agreed SUDA may float advertisement for the 23 ULBs as was done earlier.
2) To sponsor name of the experience MBBS Doctor to act as HO of Dhupguri Municipality so that he may be selected by the Municipality.	We have no panel of Doctors. So it is not possible to sponsor name of MBBS Doctor.
3) Age relaxation upto 45 – 50 years of age for experience doctor having required qualification.	In the memorandum of Dept. of Municipal Affairs vide no. 846/MA/C-10/3S-55/2005 Pt.-I dt. 8 <sup>th</sup> August, 2008, the maximum age limit for contractual engagement of a candidate for the 1 <sup>st</sup> time is fixed at 32 years. The issue of age relaxation as well as engagement of retired Government Medical Officer upto the age of 65 in extreme cases to the post of Health Officer, requested by the Chairman, may be referred to the Dept. for their consideration.
4) Retired Government Medical Officer upto the age of 65 years may be engaged as Health Officer under CBPHCS.
