Sub. : Proposal for printing & supply of Family Schedule to the 11 Non-KMA ULBs implementing HHW Scheme.

This is to intimate that DFID assisted HHW Scheme was launched in the year 2004 with the approval of Dept. of Health & Family Welfare. At the grass root level HHW maintains Family Schedule for each of the households under her jurisdiction for documentation of data which is the basis for HMIS. Each HHW is to visit 200 households, each household twice a month and enter the required information and data in the Family Schedule. With the launching of DFID assisted HHW Scheme initial supply of Family Schedule to the ULBs concerned was made during year 2004 (enclosed at Flag – A). This Family Schedules were printed centrally under the arrangement of Health, SUDA by floating tender and were supplied to the ULBs.

Provision has been kept in the said Family Schedule for use for a period of five years. This period is nearing end and the ULBs are pressing hard for supply of fresh Family Schedule for use of the HHWs.

For the purpose of procurement by SUDA in respect of HHW Scheme, a central tender committee (enclosed at Flag – B) was constituted with Jt. Secretary, Dept of MA - Chairman; Chief Engineer, MED - Member; DLB & ex. Officio Director, SUDA - Member and Project Officer, Health, SUDA - Member -Secretary.

It is now proposed that procurement may be done through inviting quotations for printing & supply of the required no. of Family Schedule directly to the ULBs concerned.
